



Quarterly brief -

January-March 2025









### Key developments

- » A new President of the Judicial Council was elected in early 2025, and the Council announced plans to introduce monthly caseload benchmarks for judges.
- » In March, the Assembly voted no confidence in five Judicial Council members over allegations of undermining judicial independence; the Prime Minister's threats of protest sparked EU warnings about political pressure on the judiciary.
- » The Academy for Judges and Public Prosecutors certified 50 future judges and 47 prosecutors.
- » In January 2025, the Assembly adopted amendments to the Law on Electronic Documents, Electronic Identification, and Confidential Services, and the Government adopted the National Cyber Security Strategy 2025–2028.
- » The latest Transparency International Corruption Perception Index marked a backsliding for North Macedonia, largely due to concerning developments in the judiciary over the past year and the impunity of individuals involved in high-level corruption.
- » In mid-February, a draft Law amending and supplementing the Law on Prevention of Corruption and Conflict of Interest was published, intended to address the identified shortcomings of the current law that negatively impact the efficiency of the SCPC, while respecting established prohibitions and responsibilities.
- » The PPO is investigating the nightclub fire in Kochani, initially discovering several anomalies in the building that were possibly concealed by corrupt practices.
- » During this quarter, developments have occurred in the process of selecting new members of the Council of the Agency for Audio and Audiovisual Media Services (AAVMS); however, they have not been finalised due to a lack of consensus in the Assembly.
- » The new Rules of Procedure for the Work of the Commission for Prevention and Protection against Discrimination (CPPD) were adopted, and the Assembly issued a public call for the election of one new member to the CPPD.
- » The Commission for Equal Opportunities between Women and Men adopted a new Action Plan for Gender Equality in the Parliament 2025–2027.

### **Elections**

In February, the Constitutional Court initiated proceedings to assess the constitutionality of Articles 17 and 18 of the recently adopted amendments to the Electoral Code. The provisions in question increase the threshold for collecting signatures required for independent candidates and electoral lists. Adopted on 7 March 2024, the amendments were intended to apply to the local elections scheduled for October 2025. The Court noted concerns regarding potential inconsistencies with fundamental democratic principles, including the rule of law, political pluralism, and equality before the law.<sup>1</sup>

### Assembly

On 10 January, the Assembly adopted a motion for interpellation against the Chairwoman of the Committee on Social Policy, Demography and Youth, with 61 votes in favour and 22 against. The motion, initiated by MPs from the political party Levica, alleged shortcomings in the Chairwoman's performance.<sup>2</sup> The Assembly concluded that the claims were substantiated, and the MP resigned shortly thereafter.<sup>3</sup> On 29 January, the Committee on Elections and Appointments endorsed a draft decision proposing seven candidates for membership in the Council of the Agency for Audio and Audiovisual Media Services (AAVMS).<sup>4</sup> The vote was scheduled for the 34<sup>th</sup> plenary session held on 12 February,<sup>5</sup> but did not proceed due to a lack of the required majority in the Assembly.<sup>6</sup>

On 18 March, in the aftermath of a deadly fire in a nightclub in Kochani that claimed over 50 lives, the Assembly suspended all scheduled activities for the following week in observance of national mourning.<sup>7</sup>

### Governance

In early February, following a fatal traffic accident that triggered public outrage over judicial accountability,<sup>8</sup> the Prime Minister announced that the ruling majority would submit motions for interpellation against five members of the Judicial Council appointed by the Assembly.<sup>9</sup> The President of the Republic supported the initiative and called for their resignations.<sup>10</sup>

In parallel, the Government initiated the dismissal of the State Public Prosecutor, citing North Macedonia's decline in the 2024 Transparency International Corruption Perceptions Index and concerns over the legality of a recent appointment within the prosecution service.¹¹ The Prosecutor rejected the accusations, asserting compliance with legal procedures and challenging the legal basis for his dismissal.¹² Despite the ongoing debate, the Government submitted the dismissal proposal to the Council of Public Prosecutors.¹³ In March, the Prosecutor reiterated that the Government's submission lacked grounds for serious disciplinary misconduct.¹⁴

On 11 March, the Assembly passed a vote of no confidence in the five members of the Judicial Council, citing their role in undermining the independence and credibility of the judiciary. The vote effectively stripped them of legitimacy to continue exercising their functions.<sup>15</sup> The decision was met with criticism from the European Parliament's rapporteur for North Macedonia, who warned that political pressure on judicial institutions threatened the separation of powers and the rule of law. <sup>16</sup> Shortly thereafter, the Prime Minister publicly stated that if the Judicial Council members did not resign, he would lead protests demanding their removal. <sup>17</sup>

By the end of March, the Government announced the withdrawal of the dismissal procedure against the State Public Prosecutor, citing the need to allow prosecutors investigating the Kochani nightclub fire to conduct their work undisturbed. A scheduled session of the Council of Public Prosecutors to discuss the matter was postponed due to a lack of quorum.

In relation to the same incident, the Mayor of Kochani submitted his resignation following the tragedy that resulted in 59 deaths and over 150 injuries.<sup>20</sup> In connection with the same tragedy, the Minister of Transport stated that 427 licenses of construction companies found to be in breach of regulations were revoked.<sup>21</sup> In the meantime, the Basic Court Kochani ordered 30-day detention for 13 people over the 'Puls' nightclub fire, including the former minister for economy.<sup>22</sup> The two former mayors of Kochani and the former director of the State Market Inspectorate were placed under house arrest, replacing their initial detention orders.<sup>23</sup>

### Civil Society

On 20 January, the Government launched a public call for the selection of 14 members and deputy members of the Council for Cooperation between the Government and Civil Society, targeting representatives from associations and foundations. <sup>24</sup> On 5 February, an additional call was issued for civil society organisations representing persons with disabilities to join the National Coordinating Body for the Implementation of the UN Convention on the Rights of Persons with Disabilities.<sup>25</sup>

Following the initial call, 18 applications were submitted.<sup>26</sup> On 6 March, the Government published the list of the 14 appointed members of the Council.<sup>27</sup> On the same day, it launched a new call to fill the positions of member and deputy member in the field of protection of marginalised persons within the Council.<sup>28</sup>

On 14 March, the Working Group for the Development of the Government Strategy for Cooperation with and Development of Civil Society 2025–2028 held its inaugural meeting.<sup>29</sup> By the end of the month, the Government had received two applications for the open positions in the field of protection of marginalised persons.<sup>30</sup>

# Civilian Oversight of the Security/Intelligence Sector

On 5 February, the Constitutional Court ruled that the dismissal of the former Director of the Intelligence Agency in June 2024 did not constitute discrimination on the grounds of gender or political affiliation, as alleged by the former officeholder.<sup>31</sup>

In the meantime, on 7 February, several schools in Skopje received bomb threats and were subsequently evacuated.<sup>32</sup>

On February 14, the National Security Agency announced the introduction of mandatory polygraph testing as part of its employment procedures, professional integrity assessments, and security clearance process, in line with the Law on the National Security Agency.<sup>33</sup>

On 27 February, the State Commission for the Prevention of Corruption (SCPC) closed proceedings against the Deputy Director of the Intelligence Agency, citing the existence of a parallel investigation by the Public Prosecutor's Office into allegations of submitting falsified qualifications. <sup>34</sup> On 7 March, the Prosecutor's Office launched a new investigation into a separate case related to the Intelligence Agency. <sup>35</sup>

### Public Administration Reform

In January 2025, the Assembly adopted amendments to the Law on Electronic Documents, Electronic Identification, and Confidential Services, which stipulate that a printed electronic document obtained by a citizen shall have the same validity as the original document.<sup>36</sup> These amendments to the law will streamline the process of obtaining documents, enabling citizens to access services on their mobile devices.<sup>37</sup>

In January 2025, the Government adopted the National Cyber Security Strategy 2025–2028.<sup>38</sup> It represents a roadmap for strengthening the resilience and security of the state in cyberspace. This strategy marks a turning point in the country's efforts to protect its digital infrastructure and build a safer, more secure future for all.<sup>39</sup> It was adopted after a three-year gap, during which the absence of a national cybersecurity framework left the country vulnerable to increased threats.<sup>40</sup>

On March 10 2025, the third session of the Secretariat for Public Administration Reform (PAR) was held, during which the draft annual report for 2024, covering the period from January to June 2024, was adopted. This report outlines the implementation of the PAR Strategy (2023–2030) with its Action Plan. Additionally, the Action Plan for planned activities in accordance with the monitoring report from the assessment mission of SIGMA from 2024 for the Republic of North Macedonia was reviewed and discussed.

In March 2025, in line with the goals defined in the Growth Plan for the Western Balkans, the Ministry of Digital Transformation (MDT) announced the preparation of the following laws: the Law on Electronic Communications; amendments to the Law on Electronic Documents, Electronic Identification, and Confidential Services; the Law on Archival Material and Archival Activities, and the Law on Network and Information Systems Security.<sup>41</sup>

• The Law on Electronic Communications aims to align the national legal framework with European standards by harmonising with the European Electronic Communications Code (2018/1972) and the Gigabit Infrastructure Act (2024/1309). The law will ensure the updating of the regulatory framework for electronic communications by promoting investments in high-quality, high-speed networks, protecting consumers, and promoting competitiveness. It will establish a comprehensive framework to support the faster, more cost-effective, and simplified deployment of high-capacity networks, commonly referred to as gigabit networks.<sup>42</sup>

- The amendments to the Law on Electronic Documents, Electronic Identification, and Confidential Services are in alignment with the EU Regulation 2024/1183. The primary goal of the law is to establish a single, unified digital identity system nationwide, enabling easy and secure access to both public and private services. This will simplify the use of electronic services and increase the number of electronic transactions between users.<sup>43</sup>
- The Law on Archival Material and Archival Activity establishes a modern legal framework for managing archival activities, including the electronic handling of archival documents, which will improve the preservation and operational efficiency of archival institutions in the country. 44
- The Law on Network and Information Systems (NIS) Security serves as the foundation for alignment with the EU's NIS 2 Directive. The law aims to ensure a high level of cyber resilience by integrating cybersecurity into every segment of digital transformation.<sup>45</sup>


Through this package of laws, the MDT establishes the legal foundation for comprehensive, fundamental, and tangible reforms in the field of information and communication technologies, as well as the country's digital transformation. With timely implementation of the planned steps, significant funds for accelerated reforms and development will be secured, which will enhance economic growth and support the country on its path to EU membership.<sup>46</sup>

### Functioning of the judiciary

### Management bodies

At the beginning of 2025, a new President of the Judicial Council was elected to succeed the previous office-holder, who had resigned.<sup>47</sup> In February, the Judicial Council announced its intention to establish a commission to define indicative caseload benchmarks for judges every month.<sup>48</sup>

### Independence and impartiality

Following the adoption of a new Rulebook in November 2024, the constitutive session of the restructured Council for the Coordination of Information and Communication Technology in Judicial Bodies (ICT Council) was held on 27 January. The Council, established in accordance with Article 87-a of the Law on Courts, comprises representatives from judicial institutions and is responsible for coordinating digitalisation efforts across the judiciary.<sup>49</sup>

In January, the Supreme Court and the Ministry of Interior signed a cooperation agreement to enable the electronic exchange of data via the National Interoperability Platform, in line with the Law on Electronic Documents, Electronic Identification and Trust Services.<sup>50</sup> At the end of the month, the Supreme Court operationalised several web services on the platform, including those for criminal and penal records, bans on professional activity, and revoked legal capacity for natural persons.<sup>51</sup>

In February, the Association of Judges elected a new composition of the Judicial Media Council for 2025, comprising eight journalists and seven judges.<sup>52</sup> The Council issued a public statement criticising the exclusion of a journalist from a court hearing in Veles, reaffirming that public access to court proceedings is a core principle of fair trial and transparency, subject only to legally prescribed exceptions.<sup>53</sup>

### Accountability

In February, following a fatal traffic accident that sparked public outrage, the Minister of Justice removed a judge from a working group established by the Ministry. The judge had imposed a non-custodial educational measure in a prior case involving the same driver accused in the recent incident.<sup>54</sup> The Judicial Council announced it would review the driver's case history given his prior offences.<sup>55</sup>

The President of the Judicial Council publicly rejected calls for the Council's dissolution, cautioning against radical reforms that could undermine the judiciary.<sup>56</sup> At the end of the month, the Council examined the findings of a working group that assessed the judge's conduct and found no basis for disciplinary action. The Council unanimously supported the judge, affirming that decisions had been taken within the bounds of legal discretion.<sup>57</sup>

On 28 February, a Judicial Council member refused to resign following interpellation votes, alleging political pressure from the executive branch and interference in judicial independence.<sup>58</sup>

Separately, media reports raised concerns over the President of the Supreme Court's compensation from the Academy of Judges and Public Prosecutors between 2022 and 2024. Despite receiving approximately MKD 400,000, she was reportedly absent from over half of the Board's sessions. The Academy stated that advance notice was not provided in time to summon a deputy, while the President claimed she had not received timely invitations.<sup>59</sup>

### Professionalism and competence

On 6 February, the Academy for Judges and Public Prosecutors 'Pavel Shatev' awarded certificates to 97 graduates of its initial training programme, including 50 future judges and 47 future public prosecutors. <sup>60</sup> On the same day, the Council of Public Prosecutors announced a call to fill 47 positions in basic public prosecutor's offices, including two vacancies in the Office for Prosecuting Organised Crime and Corruption. <sup>61</sup> The Judicial Council also opened a call for 50 new judicial appointments across the court system. <sup>62</sup>

On 10 February, the Council of Public Prosecutors elected a new president of the Higher Public Prosecutor's Office in Skopje.<sup>63</sup> However, she tendered her resignation just eight days later, citing the need to focus on casework and recommending that a more experienced colleague be appointed to the position. The Council also appointed new chiefs of the Basic Public Prosecutor's Offices in Gevgelija and Prilep on the same day.<sup>64</sup>

In March, the Council elected 31 new public prosecutors for 10 basic prosecutor's offices. No candidates were elected for the offices in Gostivar and Kičevo, while five other offices had no registered applicants. During the same period, three judges from the Bitola Court of Appeal made solemn declarations. The Judicial Council appointed new presidents for the Appellate Court in Bitola and new judges in the Basic Courts in Bitola, Veles, Gevgelija, Gostivar, Delchevo, Kavadarci, Kichevo, Kochani, Kriva Palanka, Kumanovo, Ohrid, Prilep, Sveti Nikole, Struga, Strumica, Tetovo, and Shtip. 66

On 10 March, the Judicial Council appointed an acting President of the Supreme Court by a vote of 10 to 2. The selection process for a permanent appointment remains ongoing.<sup>67</sup>

### Quality of justice

At its 229<sup>th</sup> session, held on 23 January 2025, the Management Board of the Academy of Judges and Public Prosecutors decided to increase institutional transparency by initiating public broadcasts of its sessions via the Academy's YouTube channel. The measure will be monitored for effectiveness and supplemented with additional methods if necessary.<sup>68</sup>

At the following session, the Board was updated on preparations for admitting the ninth generation of initial training candidates and adopted a resolution requesting funding from the Ministry of Finance via the Judicial Budget Council. The Academy had previously sought guidance from the Government and the Ministry of Finance regarding the future structure of the entrance examination process.<sup>69</sup>

On 26 January, the Programme Council held an online meeting to review a proposed Training Plan template developed by the Academy's Deputy Director in collaboration with staff from the Continuous Training Sector. The template aims to introduce a unified structure for lectures. Members agreed to continue refining the proposal and provide further input on its content and format.<sup>70</sup>

At its 232<sup>nd</sup> session, held at the end of March, the Management Board reviewed the text of a public call for appointing a new Deputy Director and established a commission to oversee the selection procedure.<sup>71</sup>

### Efficiency

On 5 February, the Constitutional Court annulled the Law on Solidarity Tax, finding that it undermined legal certainty and violated constitutionally protected property rights. The Court concluded that the retroactive regulation of legal relations infringed on taxpayers' legitimate expectations and the rule of law.<sup>72</sup>

Later in the month, the Court initiated a procedure to assess the constitutionality of the September 2023 amendments to the Criminal Code, which reduced penalties for abuse of office and criminal association, thereby potentially affecting the statute of limitations in several high-profile cases.<sup>73</sup>

In a unanimous decision, the Court also opened a procedure to review the Rules of Procedure of the Council of Public Prosecutors. The contested provision allows for a member's service on the Council, even without case-related duties, to be automatically considered as part of a positive performance evaluation for promotion after four years.<sup>74</sup>

The Court postponed its preparatory session on the Law on the Use of Languages due to the national mourning period following the Kochani tragedy.<sup>75</sup>

Meanwhile, the Government announced its intention to raise the retirement age for judges to 67, citing staff shortages and the need to strengthen the fight against corruption. The proposal was criticised by the opposition as discriminatory.<sup>76</sup>

### Fight Against Corruption

Toward the end of February, the State Commission for the Prevention of Corruption (SCPC), in cooperation with the United Nations Office on Drugs and Crime (UNODC) and the Regional Anti-Corruption Initiative (RAI), and the support of the Austrian Development Agency, organised a workshop on the implementation of the National Strategy for Prevention of Corruption and Conflict of Interest (2021–2025) and a roadmap for the development of a new anti-corruption strategy (2026–2030). The workshop was attended by representatives of state institutions involved in implementing the existing strategy, as well as representatives from international organisations in the country, civil society, and the private sector.<sup>77</sup>

The latest Transparency International Corruption Perception Index ranked North Macedonia 88<sup>th</sup> in the world with 40 index points, compared to 76<sup>th</sup> last year with 42 index points. Such backsliding is largely due to concerning developments in the judiciary over the past year, as well as the impunity of individuals involved in high-level corruption.<sup>78</sup>

### State Commission for Prevention of Corruption

In the second half of February, the State Commission for Prevention of Corruption (SCPC) elected a new Deputy President based on the rotation principle to serve a six-month term.<sup>79</sup>

At the end of March, the SCPC published its 2024 Annual Report. The Commission received 689 reports of suspected corruption and initiated 78 cases ex officio. It issued a total of 742 decisions: 353 related to corruption, 98 to conflict of interest, 60 to election campaign financing, and 231 to asset declarations.<sup>80</sup>

The SCPC also released its 2024 Annual Report on the implementation of the National Strategy for the Prevention of Corruption and Conflict of Interest. The report indicated that only 18% of planned activities were fully implemented, 32% were ongoing, and 50% had not commenced. The most progress was recorded in the law enforcement, health, and education sectors, while limited implementation was observed in urban planning, the environment, agriculture, and sport.<sup>81</sup>

Additionally, the SCPC published its 2024 Integrity System Monitoring Report, covering 72 central government institutions, 72 local authorities, and 16 judicial institutions. The report noted widespread shortcomings, including the absence of internal rules on conflict of interest, insufficient regulation on gifts and hospitality, low ISO certification rates, and limited integrity-related training and monitoring.

The SCPC announced its intention to regularly publish information on enforcement actions under the Law on Prevention of Corruption and Conflict of Interest.<sup>83</sup> It published the names of former and current officials fined in the past year for breaches of the law.<sup>84</sup>

#### The Public Prosecutor's Office

During this quarterly period, the Public Prosecutor of the Republic of North Macedonia amended the mandatory instruction for all public prosecutors in the country to prioritise corruption cases. Those of particular public interest concern procedures for providing data and information on bank accounts, property, or objects of interest located abroad that are relevant to corruption-related cases and pertain to all individuals involved in acts of corruption, regardless of their role or status. These amendments are the result of a meeting held with representatives of the specialised analytical centre at Europol, responsible for combating corruption, where possibilities for establishing in-depth cooperation in corruption-related cases were discussed.<sup>85</sup>

This quarter was marked by the fire that broke out in a nightclub in the city of Kochani, where initially 59 young people lost their lives and over 160 people were hospitalised. The Public Prosecutor's Office (PPO) formed a team of five public prosecutors, which initiated an investigation against 27 persons and three companies, that due to its complexity, six more public prosecutors joined the team. Their preliminary findings discovered several anomalies in the building: it did not have a hydrant or a sufficient number of fire extinguishers; it was not registered as a catering facility, but as a light industry site with an operating permit from the Ministry of Economy issued 15 years ago; it was lined with materials for sound insulation and visual effects that were easily flammable; and pyrotechnic materials were used illegally. These findings led to various institutional reactions: prison or house detention was ordered for a total of 24 suspects for serious crimes against public security; the mayor of Kochani resigned; and the SCPC launched an anti-corruption review of relevant legislation to enable the detection and prevention of potential corruption risks. Simultaneously, citizens reacted by organising protests in Kochani and other cities across the country, while the Platform of Civil Society Organisations to Fight

Corruption made public requests to competent institutions, whose completion should lead to the cessation of the practice of impunity, selective justice, and merely formal fulfilment of obligations.<sup>96</sup>

During this quarterly period, several other criminal investigations were initiated, regarding the following: a former director of the Service for General and Common Affairs of the Government of the Republic of North Macedonia suspected of accepting a bribe and embezzlement in office; five individuals and one legal entity suspected of abusing their official positions and authority, falsification of official documents and abusing the public procurement procedure for the selection of a company for physical security at 14 toll stations of the Public Enterprise 'State Roads'; and two police officers suspected of abusing their official positions and authority, falsification of official documents, and obstruction of justice to prevent the presentation of evidence in proceedings conducted before the PPO Kumanovo.<sup>99</sup>

In addition, during this period, criminal charges were filed due to reasonable suspicion of abuse of official position and authority against the following individuals: the acting director of the General Hospital in Ohrid;<sup>100</sup> a former chief of the Department for Aviation Units within the Ministry of Interior (MoI);<sup>101</sup> and a former director of the Mining and Energy Combine Bitola.<sup>102</sup>

Criminal charges were filed for other corruption-related criminal offenses against the following individuals: 31 individuals and five legal entities accused of abusing their official positions and authority, falsification of official documents, abusing the public procurement procedure, money laundering, and several other crimes related to the procurement of coal additive for the needs of the Power Plants of North Macedonia;<sup>103</sup> four persons accused of abusing their official positions and authority and abusing the public procurement procedure regarding the execution of the façade and illumination project of the Government building;<sup>104</sup> a former director of the utility company of the Municipality of Gazi Baba for embezzlement in office;<sup>105</sup> fifteen customs officers and a police officer accused of having committed the crimes of accepting a bribe and abuse of their official positions and authority;<sup>106</sup> a police officer<sup>107</sup> and a surgeon<sup>108</sup> suspected of accepting bribes on different occasions.

In the 'Tvrdina' case, the Criminal Court Skopje imposed a fourteen-and-a-half year and a nine-year-ten-month prison sentence on two former intelligence officials, respectively, for abusing their official positions and authority, and for falsification of official documents, related to the destruction of the communication monitoring systems in the former Security and Counterintelligence Directorate. A former Minister of Interior was acquitted, because the prosecution did not prove that she committed the crime for which she was accused.<sup>109</sup>

### Legal Framework

Following objections by the SCPC<sup>110</sup> and the Platform of Civil Society Organisations to Fight Corruption<sup>111</sup>, concerns were raised over the proposed amendments and supplements to the Law on Public Procurement. These concerns led to the withdrawal of the amendments and supplements from the expedited procedure and their submission under the regular legislative procedure with certain corrections.<sup>112</sup> Those amendments were adopted by the Assembly, including the contested provisions on the abolition of administrative control over public procurement carried out by the Public Procurement Bureau and on the changes to the composition of the State Commission for Public Procurement Appeals.<sup>113</sup>

In mid-February, a draft law amending and supplementing the Law on Prevention of Corruption and Conflict of Interest was published on the Unique National Electronic Register of Regulations (ENER). It was noted that these amendments are intended to address the identified shortcomings of the Law on Prevention of Corruption and Conflict of Interest, which have a negative impact on the efficiency of the SCPC and the enforcement of established prohibitions and responsibilities.<sup>114</sup>

During this quarterly period, the Ministry of Justice announced that it would soon prepare amendments to the applicable Criminal Code, which are expected to eliminate the harmful implications of the latest amendments introduced in 2023. These amendments should enhance the provisions related to the fight against corruption by increasing the existing penalties for the criminal offence of abuse of official position and authority, and by expanding the scope of criminal offences to allow for extended confiscation.<sup>115</sup> In the meantime, the Constitutional Court initiated a procedure for assessing the constitutionality of the 2023 amendments to the Criminal Code<sup>116</sup> and instructed the Assembly to amend and/or supplement them within six months to mitigate their implications.<sup>117</sup>

### **Fundamental Rights**

### Case Law of the European Court of Human Rights

The European Court of Human Rights (ECtHR) issued a judgment on 4 March in the case of K.M. v. North Macedonia. The case concerns North Macedonia's alleged failure to protect a fourteen-year-old girl from sexual abuse related to an incident in which an adult had allegedly caressed her leg and touched her breast and shoulders. The ECtHR ruled that the domestic criminal-law framework in force at the material time did not afford the requisite protection for the applicant's rights under Article 8 of the European Convention on Human Rights. It found that the lack of an effective criminal-law response to the alleged sexual abuse, resulting in the dismissal of the applicant's criminal complaint, did not correspond to the requisite respect of the best interests of the child. Furthermore, it held that the domestic civil-law provisions, as applied in practice by the domestic courts, did not afford the applicant the necessary protection against sexual abuse. The ECtHR ruled that there had been a violation of Article 8 of the European Convention on Human Rights (ECHR).<sup>118</sup>

### The Ombudsperson

In February, the Ombudsperson signed a Memorandum of Understanding with the Human Rights Department of the European Border and Coast Guard Agency (FRONTEX), to ensure cooperation between the two institutions and the exchange of information regarding the guidelines for human rights violations during the operational activities of the Agency on the territory of the Republic of North Macedonia.<sup>119</sup>

#### Prison and Detention Facilities

A series of incidents in early 2025 highlighted persistent challenges within the penitentiary system, particularly at the largest correctional facility, Idrizovo. In mid-January, a series of violent incidents were reported, including assaults on prison staff<sup>120</sup> and fights among inmates in both male<sup>121</sup> and female wards.<sup>122</sup> One prisoner physically assaulted a guard during a court transfer.<sup>123</sup> The Union of Prison Police and Administration within the Independent Union of State Administration highlighted the problems faced by prison officers. It emphasised the need to improve the rights of employees and the conditions within the prison system.<sup>124</sup> These incidents point to serious gaps in inmate supervision, internal control, and safety procedures for both staff and convicts.

Further concerns arose over alleged misconduct by prison staff. Reports indicate that a prison officer facilitated unauthorised access to a mobile phone for a high-profile inmate. The Ministry of Interior confirmed the officer's suspension. In separate inspections, 70 mobile phones and cash were discovered in inmate cells in both Idrizovo and Shuto Orizari prisons, highlighting serious deficiencies in internal control and prison governance.

In response to these issues, authorities announced measures to improve conditions and accountability. The Health Fund and the Administration for the Execution of Sanctions introduced a reform ensuring that all convicted individuals receive health insurance immediately upon entering the prison system. Previously, this coverage was delayed by up to one month.<sup>129</sup> Additionally, steps are being taken to introduce a standardised injury register to improve data collection and inform prison policy reforms.<sup>130</sup>

#### Personal Data Protection

In February, the Personal Data Protection Agency (PDPA) reaffirmed that media outlets have the right to publish personal data in the public interest, particularly in cases involving public figures. The PDPA emphasised that such reporting must comply with professional standards and not infringe upon personal dignity.<sup>131</sup>

To mark Safer Internet Day on 6 February, the PDPA launched public awareness activities targeting children and youth, promoting responsible digital behaviour and raising awareness about online data privacy.<sup>132</sup>

### Freedom of Expression

Structural challenges persist, continuing to impact media independence and the safety of journalists. In January, the Council of Media Ethics of Macedonia (SEMM) reported that online outlets remain the most frequent violators of ethical standards, with 84 complaints received in 2024. SEMM's Complaints Commission raised concerns about the disregard for self-regulation in the digital media sector and called for enhanced professionalisation and adherence to ethical norms.<sup>133</sup>

The appointment of new members to the Council of the AAVMS remained stalled. Although seven candidates passed the screening process by the Parliamentary Committee on Elections and Appointments,<sup>134</sup> the Assembly failed to secure the required two-thirds majority in February.<sup>135</sup> Media<sup>136</sup> and international actors<sup>137</sup> reiterated the need for transparent appointments based on merit, warning of the risks to regulatory independence.

In March, the Government announced a tender for the development of media monitoring software to assess news content as positive, negative, or neutral.<sup>138</sup> Media organisations warned that such tools could enable censorship and limit editorial freedom.

This quarter saw an increase in threats against journalists. In January, a female journalist's vehicle was set on fire in Veles.<sup>139</sup> Media organisations condemned the attack, linking it to a broader trend of gender-based threats.<sup>140</sup> In February, further cases emerged of personal image misuse and hate speech targeting female investigative journalists.<sup>141</sup> The Association of Journalists of Macedonia (AJM) and the Independent Union of Journalists and Media Workers (SSNM) called for institutional responses<sup>142</sup> and gender-sensitive protective measures.<sup>143</sup>

Media organisations also raised concerns about restrictions on reporting following the Kochani tragedy. Iournalists reported experiencing verbal pressure and obstruction by local officials, highlighting that, instead of supporting transparent reporting during a crisis, they sought to control the narrative or restrict media access, thereby undermining public trust and freedom of expression. The Ministry of Interior, following

a Civil Aviation Agency decision, imposed a drone ban in Shtip and Kochani during funerals.<sup>146</sup> While framed as a security measure, media stakeholders expressed concern over limitations on public documentation. The AJM and SSNM criticised the summoning of journalists for "informative talks" regarding drone usage, citing a lack of prior notice.<sup>147</sup>

Throughout the quarter, the AJM and SEMM emphasised the importance of ethical reporting on sensitive topics and advocated for institutional safeguards to ensure press freedom in practice.

### Vulnerable Groups and the Principle of Non-discrimination

The new Rules of Procedure for the Work of the Commission for Prevention and Protection against Discrimination (CPPD) were adopted, aiming to contribute to the institutional framework for addressing discrimination. The CPPD also issued an opinion identifying direct political discrimination in the appointment process of a female police commander in Star Dojran. According to the findings, the MoI selected a candidate with less relevant experience over another based on political affiliation. The case exposed ongoing challenges related to both political bias and gender equality in public sector appointments. On 17 February, the Assembly published a public call for the election of one member of the CPPD with a mandate of five years.

The first session of the National Coordinative Body for Equality and Non-Discrimination was held in February. The Minister of Social Policy, Demography and Youth emphasised the importance of this body as a practical mechanism with broad responsibilities in monitoring implementation, proposing improvements, and coordinating the state's efforts under the National Strategy for Equality and Non-Discrimination (2022–2026). A second Action Plan (2025–2026) is under preparation, aiming to consolidate inter-institutional cooperation and systematic responses to inequality.<sup>151</sup>

Regarding disability rights, the Ministry of Digital Transformation (MDT) launched consultations in January for a new Law on Accessibility, aiming to ensure that public sector websites and mobile applications are accessible to all citizens, including those with disabilities. This legislative initiative reflects alignment with EU standards on digital accessibility. Additionally, the Ministry of Education and Science has announced that students with disabilities in secondary education will begin receiving educational assistants starting from September 2025. The Ministry pledged to provide additional support where needed during the school year, contributing to a more inclusive education system. September 2025.

#### Gender

Institutional efforts to strengthen gender equality continued amid persistent challenges in implementation and alarming cases of gender-based violence.

In January, the Assembly passed the amendments to the Law on Prevention and Protection from Violence against Women and Domestic Violence (first hearing), reinforcing institutional responsibilities to ensure gender-sensitive services.<sup>154</sup> In February, the Commission for Equal Opportunities between Women and Men adopted a new Action Plan for Gender Equality in the Parliament for 2025-2027,155 and inter-institutional cooperation on gender equality was reinforced through the launch of a working group for the preparation of the National Action Plan on Gender Equality for the same period. The Commission for Financial Compensation for Victims of Violence and Rape reported receiving several applications, including from survivors of child sexual abuse<sup>157</sup> and launched a public website with the support of the OSCE mission in Skopje.<sup>158</sup> A key labour reform has also been proposed by the political party Levica—namely, to extend maternity leave to 18 months—seeking to provide extended support for new mothers, promoting better work-life balance and child care.<sup>159</sup> On the other hand, the amendments to the Laws on Primary Education,<sup>160</sup> which entered into force on 11 January 2025, removed the terms "gender," "sexual orientation," and "gender identity" from Article 5, paragraph 1, as protected grounds against discrimination in education. This change directly contradicts the existing Law on Prevention and Protection against Discrimination, which explicitly includes these categories. By excluding these protections, the amendments weaken institutional safeguards against discrimination and violence, particularly for LGBTI students and girls.

In March, the working group for the improvement and implementation of the standard operating procedure for referral centres for victims of sexual violence held its first meeting.<sup>161</sup> The goal of the working group is to identify shortcomings and challenges in the functioning of the sexual violence referral centres established at three public health institutions—procedures that are not aligned with the Istanbul Convention—and, based on that, to propose amendments and improvements to the standard operating procedure.<sup>162</sup>

Following public backlash from civil society, including the National Network against Violence against Women<sup>163</sup> and the Gender Equality Platform,<sup>164</sup> the Ministry of Interior withdrew draft amendments to the Law on Police<sup>165</sup> that would have allowed officers accused of domestic violence to retain their weapons during proceedings.

Controversy arose after a government minister made a discriminatory remark toward a female MP in February, based on marital status.<sup>166</sup> The incident was widely condemned by various actors,<sup>167</sup>—including the opposition<sup>168</sup> and the president,<sup>169</sup>—and prompted a formal complaint to the equality body.<sup>170</sup>

Gender-based violence and femicide remained in the spotlight, including a high-profile femicide case in which a woman was murdered by her extramarital partner in November 2024. The partner confessed to the murder during a court trial, receiving a life sentence. Another case, involving a woman who killed her abusers after years of psychological and physical abuse, renewed debate over recognising self-defence in such contexts. March, public outrage followed the livestreamed assault of a pregnant woman in Radovish the suspect was detained and committed to psychiatric care. To mark International Women's Day on 8 March, women's rights groups announced protest marches and a boycott of large supermarket chains—drawing attention to gender inequality and the inadequate institutional response.

#### LGBTI+

The annual Trans Visibility March was cancelled out of respect for the victims of the fatal fire in Kochani, and the organisation expressed solidarity with the affected families. This gesture was also seen as an effort to foster understanding and empathy between the LGBTI+ community and the broader public during a sensitive time.<sup>178</sup>

#### Roma

The Commission for Prevention and Protection against Discrimination (CPPD) concluded that the Public Transportation Company (JSP) had discriminated against Roma residents of the Shuto Orizari Municipality based on their ethnicity and skin colour. Operational irregularities on bus lines serving Roma-majority areas were cited as evidence of this.<sup>179</sup> In their decision, they stated that access to public transportation is an important tool for the social and economic inclusion of Roma, and that the absence of such access contributes to their further marginalisation.

The first meeting of the National Coordinative Body for the Roma Strategy was held in February. The body is tasked with overseeing the implementation of the Roma Strategy 2022–2030 and ensuring inter-institutional coordination on measures promoting inclusion, equality, and the socioeconomic development of Roma communities. The session reaffirmed the government's commitment to advancing the rights of Roma citizens and improving the effectiveness of targeted policies.
