July-September 2025









Key developments

- » In July, the three key PAR laws were adopted: the Law on Administrative Servants, the Law on Public Sector Employees, and the Law on Professional Development of Administrative Servants.
- » The Public Financial Management Reform (PFM) Programme for the period 2025–2028, along with its Action Plan for 2025, was adopted.
- » At the beginning of August, the Assembly announced the upcoming local elections—the eighth since the country's independence.
- » At the same time, an announcement for the election of a new president of the SCPC was published; however, the selection was suspended due to the pending local elections in the country.
- » The SEC adopted a new rulebook allowing independent candidates to run in the upcoming local elections if they are endorsed by the signatures of only two citizens.
- » The new Commission for the selection of candidates for judges in the ECtHR was formed, and a new public call for applications was published in September.
- » In July, the Assembly decided to issue a public call for the election of a new Ombudsperson; however, the selection has not been made yet, and thus the office of the Ombudsperson now functions with only two vice-Ombudspersons for the entire country.
- » The draft Law on Probation was published.
- » In September, the Law on Accessibility of Websites and Mobile Applications of Public Sector Institutions was adopted.
- » In late September, the constitutive session of the National Coordinating Body for the Implementation of the Council of Europe Convention on Preventing and Combating Violence against Women and Domestic Violence was held.
- » In August, the National Action Plan on Children's Rights 2025–2029 was adopted.

Elections

On 9 August, the President of the Assembly announced the upcoming local elections—the eighth since the country's independence. The first round of elections for mayors and councillors in 80 municipalities and the City of Skopje will be held on 19 October. In municipalities where the mayoral election is not completed in the first round, a second round is scheduled for 2 November. During these elections, citizens will vote for mayors and municipal councillors across 80 municipalities, including the City of Skopje. The State Election Commission (SEC) adopted the deadlines for holding the local elections on the same day, following their previous announcement by the President of the Assembly. The election campaign for the first round begins on 29 September and will last continuously until 17 October. The campaign for the second election round will last until 31 October.² Just a few days later, the former president of the State Commission for the Prevention of Corruption (SCPC) and current independent candidate for mayor of the Municipality of Centar announced on her Facebook profile that, only 11 hours after declaring her candidacy, police officers arrived at her home to inform her of criminal proceedings initiated against her.³ The Basic Public Prosecutor's Office in Skopje stated the criminal charges against the former president of the SCPC and current independent candidate for mayor of the Municipality of Centar, highlighting that it was merely an invitation for questioning and had no connection to her political activities. The next day, at a special session, the Assembly voted on proposed amendments to the Electoral Code that would require independent lists of councillors and mayoral candidates to gather signatures from 0.95 per cent of registered voters in the respective municipality or the City of Skopje. During the committee debate, the political party Levica proposed an amendment to reduce the threshold from 0.95 per cent to 0.5 per cent—an amendment supported by all parties except the European Front. When the proposal returned to the plenary session, 66 MPs voted in favour and 18 opposed. However, during the vote of the non-majority communities, 11 MPs supported the amendments while 18 voted against, resulting in their rejection due to the lack of a Badinter majority.⁵

The next day, the SEC adopted a new rulebook allowing independent candidates to run in the upcoming local elections with the endorsement of just two citizens. Under this rulebook, independent candidates for both mayoral and councillor positions must collect two signatures to qualify for participation. The decision was approved at a session with six votes in favour and one against. The rulebook was proposed by an SEC member who referred to Article 63 of the Electoral Code, noting that it remains in force and regulates the procedure for collecting signatures for candidate nominations, despite Article 62—which specifically pertains to local elections—being repealed by the Constitutional Court.⁶ Next, a member of the SEC filed a lawsuit with the Administrative Court, challenging the SEC's guideline on the number of municipal councillors, following a government decision based on the 2021 census that reduced the number of councillors in 14 municipalities.

The decision was passed with five votes in favour and one against, despite the SEC member's request for a consensus vote. The Municipality of Gostivar experienced the largest reduction, from 31 to 23 councillors, reflecting a population drop from 80,000 in 2002 to 60,000 in 2021. Opposition party DUI also appealed to the Constitutional Court, claiming the decision was unconstitutional and had marginalised Albanians. At the same time, VLEN criticised DUI for allowing the distinction between residents and non-residents in the census. In September, the Assembly adopted a Declaration on holding fair, free, and democratic elections for municipal and City of Skopje councils, with 73 votes in favour and none against. Submitted by the Assembly President and parliamentary group coordinators, the Declaration emphasises non-partisan unity, respect for citizens' voting rights, and condemnation of family and group voting as a means to manipulate election outcomes. Next, the Constitutional Court decided not to initiate proceedings concerning the SEC Rulebook, which allows independent candidates for mayor and councillors to run in the 19 October local elections with just two citizen signatures. The Court concluded that the SEC's action was necessary to ensure independent citizens could participate in the electoral process and to uphold the Constitution and the Electoral Code.

Additionally, a few days later, the Constitutional Court decided not to initiate proceedings regarding the Government's decision to reduce the number of councillors in certain municipalities. Following the 20th session, the Court's President and Judge Rapporteur held a press conference to address questions about the decision on determining the number of municipal councillors in Macedonia. The case reached the Court after three initiatives were filed by MPs of the European Front challenging the Government's decision.¹⁰ At the end of the month, the SEC finalised the voter list, confirming that 1,832,415 citizens were eligible to vote. This included 112,000 voters temporarily abroad, 2,162 voters in detention or serving prison sentences, and 450 voters residing in nursing homes.¹¹ Finally, the Agency for Audio and Audiovisual Media Services (AAVMS) unanimously adopted guidelines for broadcasters for the 2025 local elections, effectively preventing the party Levica from accessing paid political advertising. In response, Levica filed a complaint with the AAVMS, arguing that the guidelines discriminate against smaller parliamentary parties and demanding urgent revisions.¹²

Governance

The parents of the victims of the tragic fire in Kochani continued their protests. During the reporting period, they, along with relatives, friends, and supporters, marched through the city every Saturday in the "March of the Angels," demanding justice and accountability for the victims. Regarding the court proceedings related to the fire in Kochani, the case—initiated after an indictment was filed by the Kochani Basic Public Prosecutor's Office at the Basic Court of Kochani—has been transferred to the Basic Criminal Court of Skopje. This followed a decision by the Supreme Court of the Republic of North Macedonia, which accepted the proposal and designated the Skopje Basic Criminal Court as having competent and territorial jurisdiction to handle the indictment. The Supreme Court reached this decision after determining that the Basic Courts in Shtip and Strumica lack a sufficient number of criminal judges.

In July, the Assembly, with 71 votes in favour and none against or abstaining, approved the interpellation on the work of the State Public Prosecutor, submitted by the Levica party. It concluded that the allegations against the prosecutor were well-founded and forwarded this conclusion to the Government and the State Public Prosecutor.¹⁵ The following day, the State Public Prosecutor announced that he would not resign and would instead focus even more on his work.¹⁶

In the meantime, the Minister of Foreign Affairs and Foreign Trade (MFA) and the British Foreign Secretary signed a Declaration on a Strategic Partnership between North Macedonia and the United Kingdom at the Foreign Office in London. According to the Minister, the agreement strengthens the strategic relationship between the two countries, enhancing cooperation in foreign policy, security, and defence, particularly within NATO.¹⁷

At the same time, a total of 828 projects worth EUR 225 million were signed between the Government and the municipalities that applied and were selected in the second call for financing through the Hungarian loan. The largest share went to transport, with EUR 132 million for 589 projects, followed by 143 projects in the environment sector and 48 projects in education.¹⁸

Finally, the MFA invited the Bulgarian ambassador to deliver a formal démarche in response to statements by the Bulgarian Foreign Minister. During a television appearance, the minister claimed that by removing references to the "Macedonian language and identity" from the European Parliament (EP) report on North Macedonia, they prevented the EP from being used for domestic political propaganda by the Prime Minister or "North Macedonia". The MFA conveyed the démarche to the Bulgarian ambassador, noting the inappropriateness and diplomatic impropriety of such public remarks by a high-ranking government official.¹⁹

Civil Society

On 25 September, the fourth session of the Council for Cooperation between the Government and Civil Society was held. The session covered the following items: the Rules of Procedure and the 2025–2026 Work Programme of the Council for Cooperation between the Government and Civil Society; proposed amendments to the Law on Associations and Foundations; the 2024 report on financing association and foundation activities from state and local budgets; the report on Council representatives' participation in the Commission for Allocation of Financial Resources; and the nomination of a civil society representative for the working group preparing the 2027–2029 Transparency Strategy.²⁰

Civilian Oversight of the Security/Intelligence Sector

In August, it was reported that the National Security Agency (NSA) submitted three reports to the Public Prosecutor's Office regarding a former director and several NSA employees, alleging illegal, unprofessional, and unethical conduct. According to the NSA, the reports stem from an internal investigation conducted after the 2024 change of government and cover actions between 2019 and 2024.²¹

Following this, a session of the Commission for Supervision of the Work of the NSA and the Intelligence Agency (IA) was scheduled for 5 September to examine allegations of illegal wiretapping between 2019 and 2024, but it was postponed. MPs from both the ruling VMRO-DPMNE and the opposition SDSM had called for the session following claims by the current NSA director and the Prime Minister that illegal wiretapping took place during that period.²²

On 10 September, the Parliamentary Commission for Oversight of the NSA and the IA voted overwhelmingly to conduct an oversight visit to the NSA, amid allegations of wiretapping and misconduct between 2019 and 2024. During the visit, MPs reviewed documents and examined the scope of alleged illegal, unethical, and unprofessional actions by the former director and staff. They stressed that the oversight serves the public interest and expressed hope for at least partial declassification of documents to provide a detailed report. Key questions focused on the roles of senior personnel and the measures taken against political actors while they were in opposition.²³ After members of the Parliamentary Committee for Oversight of the Work of the NSA and the IA paid an oversight visit to the NSA on 10 September and to the IA on 11 September, an MP from VMRO-DPMNE used inflammatory language to call on the prosecution to take strong action, criticising what he described as clear legal violations and abuses that should already have led to charges, and demanding accountability.²⁴

Public Administration Reform

In July 2025, an organised corruption scheme was uncovered in the Agency for Administration (AA): three employees (the head of IT, an associate for exam administration, and the Secretary General) arranged exams for administrative officials in exchange for bribes, enabling unqualified candidates to receive the highest scores and secure employment. The case was revealed after a lengthy investigation involving special measures, and documents confirmed that the practice had existed over a long period and under different governments. The three entered into plea agreements with the prosecution, admitted their guilt, received suspended sentences, and one of them was banned from holding public office for five years. Their employment was terminated in August 2024.²⁵

In July, the Trade Union for Employees in the State Administration (UPOZ) and the union organisation within the AA demanded a 30% salary increase for employees in the Candidate Selection Sector, warning of a work stoppage if their demand is not met. They emphasised that staff work under significant pressure and tight deadlines, which negatively affects their health and private lives. Nearly 80% of employees earn below the national average salary, staff turnover is steadily increasing, and unlike other institutions, the AA does not approve funds for promotions or new hires, leaving employees undervalued, overburdened, and exhausted.²⁶

A year after promising a 10% cut to North Macedonia's public sector, the government is instead expanding hiring across ministries and agencies ahead of October's local elections. Officials describe this as part of a staffing plan, but the opposition and unions accuse VMRO-DPMNE of filling jobs with loyalists to boost electoral support. The exact number of public employees is unclear, as the government has delayed releasing this year's employment report.²⁷

On 10 July, the Assembly adopted three key PAR laws: the Law on Administrative Servants, the Law on Public Sector Employees, and the Law on Professional Development of Administrative Servants. The laws aim to ensure merit- and competency-based employment and promotion in public administration through a transparent digital system, enhanced working conditions for IT professionals, incentives for young talent, mandatory training via the Academy, structured mentorship, and clear criteria for advancement and accountability, all under centralised control and institutional oversight.²⁸

On 2 September, the Government adopted the following documents: the Public Financial Management Reform (PFM) Programme for the period 2025–2028²⁹, along with its Action Plan for 2025,³⁰ and the Monitoring Report on the Implementation of the PFM Reform Programme for the period January–December 2024.³¹

On 18 September 2025, the Minister of Public Administration and representatives of the Support for Improvement in Governance and Management/Organisation for Economic Co-operation and Development (SIGMA/OECD) held a working meeting to prepare the Law on the Organisation and Work of State Administration Bodies (ZORODU). The preparation of the Law on Senior Executive Service and the Law on the Salary System is also underway.³²


The Ministry of Public Administration (MPA) has launched a professional development programme for civil servants in accordance with the latest Law on Professional Development. In its first phase, 1,000 employees will be included, with more than 500 already starting standardised training in Skopje. The programme is supported by international partners, including the Regional School of Public Administration (ReSPA), the Center of Excellence in Finance (CEF), the French Agency for Vocational Training, the Vita Institute, and the Faculty of Economy. It will continue in the coming months with regional training sessions across the country.³³

The MPA and the Embassy of France have signed a Memorandum of Cooperation for a project aimed at modernising institutions and building a professional and trustworthy public administration. The project "Strengthening Capacities and Professionalization of the Administration," carried out in partnership with the National Institute of Public Administration of France (INSP), the Directorate-General for Administration and the Civil Service (DGAFP), as well as the Center for Change Management (CUP), aims to establish an Academy for the training and professional development of administrative officials and to enhance professionalisation through experience-sharing and innovative pilot training programmes.³⁴

Functioning of the judiciary

Management bodies

At its 28th session on 30 September 2025, the Council of Public Prosecutors of the Republic of North Macedonia adopted a decision to terminate the position of President of the Council due to the expiration of the mandate on 1 October 2025. The Council also decided to postpone the election of a new President until the ongoing local elections are concluded. Until a new President is elected, the Council will be chaired by the Deputy President, whose mandate remains in effect.³⁵

Independence and impartiality

At its 253rd session on 28 July 2025, the Judicial Budget Council once again reviewed the issue of the Ministry of Finance's failure to grant consent for fixed-term employment. Considering the adverse impact on court operations due to staff shortages, the Council members agreed to send a second letter requesting that the Ministry of Finance approve fixed-term employment in the courts.³⁶ Next, at its 534th session, the Judicial Budget Council reviewed a notification from the Ministry of Finance stating that financial resources had not been allocated for the requested fixed-term employment in the judiciary.³⁷

Accountability

At its 526th session, the Judicial Council deliberated on the reports concerning the factual and established situations following the submission of requests to determine the liability of judges. It decided to terminate the procedure in five cases regarding the liability of judges, while no decision was reached in one case. Additionally, the Council established Commissions of Rapporteurs to review the submitted requests to determine the liability of judges and court presidents.³⁸

Professionalism and competence

At its 525th session, the Judicial Council appointed Acting Court Presidents for Gostivar, Debar, Sveti Nikole, and Skopje to serve until new Court Presidents are elected.³⁹ At its 526th session, the Judicial Council appointed a new president of the Basic Court Ohrid.⁴⁰

At its 26th session on 4 July 2025, the Council of Public Prosecutors of the Republic of North Macedonia adopted decisions to appoint a public prosecutor as the Chief Public Prosecutor of the Basic Public Prosecutor's Office in Kichevo, and another public prosecutor as the Chief Public Prosecutor of the Basic Public Prosecutor's Office in Struga.⁴¹

Next, at its 27th session on 16 July 2025, the Council of Public Prosecutors of the Republic of North Macedonia adopted a decision to appoint two public prosecutors to the High Public Prosecutor's Office in Skopje, and also approved the appointment of two public prosecutors to the Basic Public Prosecutor's Office for the Prosecution of Organized Crime and Corruption (BPPOPOCC).⁴²

Quality of justice

In July, the Blueprint Group for Judicial Reform expressed concern over the decision of the Board of Directors of the Academy of Judges and Public Prosecutors, adopted at its 235th session on 24 June 2025, which appointed the Special Advisor to the Minister of Justice as a member of the Programme Council of the Academy. According to the group, publicly available information indicates that the appointed Programme Council member serves as a Special Advisor to the Minister of Justice. This position does not qualify as a managerial civil servant under the Law on Administrative Servants, but instead constitutes a fixed-term engagement under the Law on Public Sector Employees.⁴³

Following this, at its 236th session, the Board of Directors of the Academy of Judges and Public Prosecutors reviewed the decision, adopted on 24 June 2025, regarding the appointment of a new member to the Programme Council of the Academy. Following the review, the Board instructed the Academy to formally address and consult the Ministry of Justice of the Republic of North Macedonia to determine whether the appointment complies with the law. At the same session, a judge of the Basic Civil Court Skopje was appointed as a deputy member of the Management Board of the Academy of Judges and Public Prosecutors, following a nomination submitted by the Association of Judges of the Republic of North Macedonia. Subsequently, the Academy sent a letter to the Ministry of Justice regarding the Western Balkans Growth Plan 2024-2027, in which the Academy is included under reform 5.2.1, specifically the step stating that vacant positions for judges and prosecutors are to be filled regularly based on the projections of the Supreme Court and the State Public Prosecutor's Office after the implementation of the Human Resources Management Strategies in the Courts and Prosecutor's Offices (scheduled for December 2024 and again in December 2026). Additionally, the Academy referred to a regulation on the implementation and control of the Western Balkans Reform and Growth Instrument, adopted by the Government of the Republic of North Macedonia on 20 May 2025, and submitted a table regarding the Growth Plan to the Ministry of Justice. The Academy also submitted a request for an amendment to the Law on the Academy of Judges and Public Prosecutors to the Ministry of Justice.44

At its 237th session, the Management Board of the Academy of Judges and Public Prosecutors approved, at the contested member's request, the termination of his mandate on the Programme Council. Following this, the Academy was required to submit a request to the Ministry of Justice of the Republic of North Macedonia for the appointment of a new Programme Council member within 30 days from the date of the mandate termination decision.⁴⁵

At its 239th session, the Management Board of the Academy of Judges and Public Prosecutors was informed by the Academy's Director about the progress in implementing the steps of the Reform Agenda 2024–2028,

specifically regarding the filling of vacant judicial and public prosecutor positions. Following this update, the Management Board instructed the Academy to address the Ministry of Finance, through the Judicial Budget Council, to request confirmation of whether funds have been allocated for the admission of 130 students from the Academy's ninth generation in 2026.⁴⁶

Efficiency

The Basic Public Prosecutor's Office in Bitola established an investigation centre aimed at strengthening its investigative capacities. Initially, two investigators have been employed to begin operations. Such investigative centres are already operating in the prosecutor's offices in Skopje, Tetovo, Kumanovo and in the Basic Public Prosecutor's Office for Prosecution of Organized Crime and Corruption.⁴⁷

Fight Against Corruption

The Council of Europe Group of States against Corruption (GRECO) published a new report under the Fifth Evaluation Round for North Macedonia, taking into account the progress achieved by the country in implementing its recommendations to prevent corruption within the top executive functions of the central government and the police. The report concludes that North Macedonia has satisfactorily implemented 17 of the 23 recommendations, while the rest remain partly implemented. Steps taken to improve transparency and promote integrity with regard to persons entrusted with top executive functions, such as the government's new rules of procedure and the creation of an electronic database to register and verify the asset declarations of elected and appointed public officials, were welcomed in the report.⁴⁸

State Commission for Prevention of Corruption

The investigation of the President of the SCPC for allegedly disclosing official secrets in the "Aditiv" case,⁴⁹ concluded with an indictment against her for that criminal act.⁵⁰ Additionally, the investigation revealed that she had an auditor from the State Audit Office (SAO) pass an exam on her behalf, allowing her to obtain a security clearance certificate for access to information classified as a state secret.⁵¹ This prompted another indictment against her for computer forgery, while the SAO removed the auditor from performing audits and revoked his own security clearance certificate.⁵² Shortly after, the President of the SCPC resigned from her position, and the Assembly confirmed her resignation.⁵³ She submitted a request to the SAO to return to her previous position of assistant to the Chief State Auditor,⁵⁴ while at the end of September, the court trial against her for the aforementioned crimes began.⁵⁵

At the beginning of August, the Assembly published a decision to issue a public announcement for the election of a new president of the SCPC, following which a committee was formed to select candidates for that position. ⁵⁶ Thirteen candidates applied, ⁵⁷ however, the Assembly suspended the selection due to the pend-

ing local elections in the country.⁵⁸ In mid-August, the SCPC elected a new Deputy President from among its members, in accordance with the principle of rotation.⁵⁹

In mid-September, a consultative meeting with civil society organisations (CSOs) was held as part of the preparation of the National Strategy for Prevention of Corruption and Conflict of Interest 2026–2030. Namely, the SCPC met with representatives of the Platform of Civil Society Organizations Fighting against Corruption to review and discuss the prepared Corruption Risk Assessment for the purpose of preparing the Strategy and the methodology for its preparation.⁶⁰

During the entire reporting period, the SCPC conducted preparatory activities ahead of the pending local elections. Working meetings were held with the SEC⁶¹ and the Public Prosecutor's Office⁶². A memorandum of cooperation was signed with the SEC and the SAO to strengthen their commitment to direct cooperation, coordination, and mutual assistance in implementing the legal provisions on financing election campaigns, the exchange of information and data, and the timely action following potentially identified election irregularities.⁶³ The SCPC also issued a public notice to inform all state institutions, political parties, participants in the electoral process, as well as the general public about the legal possibilities for using budget funds in accordance with the Law on Prevention of Corruption and Conflict of Interest and the Electoral Code.⁶⁴ It also informed the public that, pursuant to the legal obligation of all public funds, public enterprises, and all other legal entities with state capital, they are required to submit data to the SCPC on all official vehicles at their disposal. However, only 42% of them submitted such data.⁶⁵

The Public Prosecutor's Office

Following an investigation initiated by the BPPOPOCC, an indictment was filed against 36 individuals (doctors, lawyers, and other official persons) organised into two criminal groups that mediated and illegally enabled the acquisition of rights to someone else's care and disability pension, in exchange for money over the past two years. The case, titled "Sindrom," revealed reasonable suspicion of several committed criminal offences, namely: criminal association, accepting and giving a bribe, and receiving a reward for unlawful influence. Thus far, 13 defendants have entered into plea agreements with the prosecution, and, based on these, the Basic Criminal Court Skopje has pronounced several verdicts. For the rest, the public prosecution has proposed to the court that the security measures already imposed on them be extended.⁶⁶

The trial of the former directors of the Radiotherapy and Oncology Clinic in Skopje, within the case "Onkologija 2," began. The defendants are charged with abuse of official position and authority, fraud, and embezzlement in the service, for causing damage to the budget of over MKD 2.2 billion by illegally purchasing medicines without the consent of the Health Insurance Fund. During the hearing on 12 September, both defendants stated they do not feel guilty, and the court proceedings are ongoing.⁶⁷

In the case against the former director of the National Agency for European Educational Programs and Mobility, the Basic Criminal Court Skopje declared her guilty of abuse of official position and authority and sentenced her to two years in prison. It was determined that she worked contrary to the Law on Public Procurement and the Law on the Establishment of the National Agency for European Educational Programs and Mobility when concluding contracts with collaborators, experts, and trainers, as she did not announce a public competition and discriminated against potential candidates, giving preference to several individuals, and acted contrary to the principles of economy, efficiency, and effectiveness.⁶⁸

Aside from the aforementioned cases, criminal charges were also filed for the following: abuse of official position and authority against the former acting president of the Council for Promotion and Supervision of Audit of the Republic of North Macedonia⁶⁹ and against the current mayor of the Municipality of Struga,⁷⁰ as well as against a former director of Skopje Prison and two prison police officers;⁷¹ receiving a reward for unlawful influence and accepting a bribe by six police officers and two other persons;⁷² accepting a bribe by the director of a public health institution⁷³ and by a doctor from another hospital;⁷⁴ and criminal association, abuse of official position and authority, and giving and accepting a bribe by fifteen persons, among whom are the director of a branch office of the Public Enterprise "National Forests," the chief of the Delchevo police, and several police officers.⁷⁵

Fundamental Rights

The 2024 Country Report of the U.S State Department on Human Rights Practices for North Macedonia determined that there were no significant changes in the human rights situation in the country during the year. However, significant human rights issues included credible reports of serious restrictions on freedom of expression and media freedom, including violence and threats of violence against journalists.⁷⁶

Case law of the European Court of Human Rights

During the reporting period, several developments occurred regarding the election procedure for a new judge from North Macedonia to the European Court of Human Rights (ECtHR). In July, the Government of North Macedonia annulled the previously submitted list of three candidates for the position of judge at the ECtHR in Strasbourg, stating that it found none of the three candidates met the required criteria. Reactions followed from the previous candidates, Calling on the government to explain why the call was annulled, when the previous commission had deemed the applicants eligible, and also revealing the "friendly suggestions" received to withdraw their candidacy for the position of judge. Reactions followed from civil society as well, Criticising the decision as non-transparent and legally questionable, arguing that by rejecting the list without explanation and dissolving the previous selection commission, the Government undermined the credibility, independence, and fairness of the selection process.

The new Commission for the selection of candidates was formed on 25 July,⁸¹ with its first meeting held on 25 August.⁸² At the first meeting, the Commission agreed that the call would last 30 days, twice as long as before, and that they would spend another month evaluating, interviewing, and selecting the three candidates. On 2 September, the Commission had its second meeting to finalise the call for candidates, after not being in full composition at prior sessions and therefore deferring the decision. The public call for applications was published on 4 September and again on 11 September.⁸³ The interviews of the applicants are scheduled to be held in October, after the 30-day deadline.

In August, the ECtHR accepted a complaint filed by the Macedonian Young Lawyers Association, which accuses municipal and national institutions of failing to fulfil their legal obligations to protect the right to a

healthy environment and public health.⁸⁴ The complaint concerns the case of the toxic municipal landfill in the town of Struga after domestic courts, including the Basic Court in Struga and the Appellate Court in Bitola, declared themselves incompetent to hear the case of the municipal landfill.⁸⁵

The Ombudsperson

On 10 July, the Assembly of North Macedonia voted on a decision to issue a public call for the election of a new Ombudsperson⁸⁶, as the mandate of the former Ombudsperson had ended on 12 July and was officially declared on 17 July by the President of the Assembly.⁸⁷ Reactions followed from the Ombudsperson himself, stating that he repeatedly informed both the Assembly and the government about the need to launch the new appointment process on time, and he argued that their failure to do so constitutes a breach of the law governing the Ombudsman's office.⁸⁸

Additionally, the Network for Protection Against Discrimination called on the Assembly to base the selection process on merit, independence, and transparency, and to refrain from partisan deals, ensuring that the process is inclusive, open, and aligned with EU and national standards for the rule of law.⁸⁹ Seventeen candidates applied to the call.⁹⁰

The Elections and Appointments Committee in the Assembly held a session on 31 July, where the candidate from the coalition VLEN was proposed as the new Ombudsperson. The Network for Protection against Discrimination criticised the selection as politically driven and non-transparent, warning that nominating a party-affiliated candidate undermines the institution's independence and credibility. It urged the Assembly to ensure an open, merit-based process that safeguards the Ombudsman's impartial role in protecting citizens' rights from political influence. In protecting citizens' rights from political influence.

However, the proposed candidate failed to secure election to the Assembly, as it was unable to secure the required "Badinter majority," thus further undermining the institution's capacity and independence. The office of the Ombudsperson now operates with only two vice-Ombudspersons for the entire country. 94

Prison and detention facilities

The Ministry of Justice published the new draft Law on Probation, which brings substantial changes aimed at improving justice, protecting victims, and making the probation service more efficient.⁹⁵

During the reporting period, a series of critical controversies continued to underscore the chronic problems in North Macedonia's penitentiary system. An indictment was submitted against the former director and seven other employees of Shutka Prison for knowingly and intentionally escorting convicts in 2024 from the prison to their homes or other locations for private purposes, contrary to procedural rules. On the other hand, the same prison is currently facing another issue: the Basic Criminal Court Skopje sent an open letter to the management of the prison regarding the failure to escort convicts to scheduled hearings, leading to the postponement of cases. The prison's current director responded that the institution faces shortages of staff and vehicles, which hamper escort processes.

Other prisons did not lack incidents either. In the male department of Idrizovo Prison, a convict assaulted a prison police officer,⁹⁸ while in the female section of the prison, a 14-year-old convict was kept locked in a cell for up to 22 hours a day because there is no separate juvenile girls' facility.⁹⁹ The Ombudsperson opened a case regarding the child and managed to get her transferred to the Tetovo Correctional Facility in Volkovija, where she now has an entire building to herself.¹⁰⁰

At the beginning of the school year, the Ombudsperson stated that classes at the Tetovo Correctional Institution did not start on 1 September. He subsequently raised the issue with the Ministry of Education and Science, but they had not responded to his concerns.¹⁰¹

According to the Council of Europe's 2024 Annual Penal Statistics on Prison Populations (SPACE I), prison overcrowding remains a critical challenge in one-third of European prison administrations, where overall, the number of inmates per 100 places available increased from 93.5 to 94.9 from 31 January 2023 to 31 January 2024, while North Macedonia reported moderate overcrowding.¹⁰²

The Administration for Execution of Sanctions signed a Memorandum of Cooperation with the Minister of Agriculture, Forestry and Water Management, to establish cooperation between the institutions for the provision of state-owned agricultural land for the performance of agricultural activities by convicted persons

as a significant step in the process of resocialisation and professional training, enabling them to acquire practical skills in agriculture. 103

Personal data protection

In September, the Personal Data Protection Agency (PDPA) signed a memorandum of cooperation with the Ministry of Digital Transformation, confirming the mutual commitment and interest in promoting cooperation between the two institutions, especially with the PDPA providing relevant training and assistance in complying with the regulations in the area for which the Ministry is responsible, with the regulations on the protection of personal data.¹⁰⁴ In addition, a training session was organised on the topic of security in personal data processing, which presented the recent updates of the Personal Data Security Regulation and reviewed the obligations of controllers and processors in detail.¹⁰⁵

Freedom of expression

The Independent Trade Union of Journalists and Media Workers (SSNM) called for an urgent increase in the minimum wage, in order to preserve the dignity of journalists and media workers, in a society where more than 50% of media employees have incomes below the national average, and a large part of them earn only a minimum wage. 106

Preparations began for the upcoming local elections, scheduled to be held in the second half of October. After they were announced, the Agency for Audio and Audiovisual Media Services (AAVMS) began monitoring broadcasters in the same manner as before the start of the election campaign. Until the start of the election campaign, AAVMS will conduct daily monitoring of nine television programme services at the state level, with the largest average daily audience reach, while all other programme services will be monitored based on complaints.¹⁰⁷

The Coordinating Body, responsible for handling complaints regarding violations of the Code of Conduct in the Online Space during Election Processes and Referenda, was reactivated and held its first meeting,¹⁰⁸ as a mechanism for protecting and respecting the right to freedom of expression and information.¹⁰⁹

The SEC received a total of 352 applications for registration in the register of broadcasters, print media, electronic media, and internet portals for the 2025 Local Elections, out of which 33 are television stations, 42 are radio stations, eight are print media, and 246 are internet portals. Approximately EUR 6.5 million will be spent on paid political advertising in the media, or 66% of the SEC's total budget for the local elections.¹¹⁰

The Association of Journalists of Macedonia (AJM) warned that the current Electoral Code does not provide clear criteria for which online media outlets are allowed to receive funds for paid political advertising, which creates room for potential party-media corruption, as some of the "portals" are websites with an unknown owner or without an imprint, often newly created before elections with the sole purpose of pouring state money into party campaigns.¹¹¹ On the other hand, political parties participating in the elections accused the AAVMS of preventing them from accessing advertising in traditional media at the national level ahead of the elections.¹¹²

In September, allegations emerged regarding illegal surveillance by the NSA, which filed a criminal report with the Basic Public Prosecutor's Office, alleging that a previous NSA director had monitored media outlets and contacts related to the opposition.¹¹³ The SSNM and AJM responded with concern, emphasising that any covert surveillance of journalists or media workers represents a serious threat to freedom of expression, the citizens' right to information, and democracy.¹¹⁴ The Basic Public Prosecutor's Office for Prosecution of Organized Crime and Corruption stated that it is investigating the case.¹¹⁵

During this quarterly period, there have been several incidents in which journalists and media crews were attacked. A media crew was reporting on a landfill that caught fire at the beginning of July,¹¹⁶ when they were physically attacked and their equipment was ruined.¹¹⁷ The AJM¹¹⁸ and the SSNM¹¹⁹ condemned this event, and the Basic Public Prosecutor's Office Skopje filed an indictment,¹²⁰ pursuant to which the Criminal Court Skopje pronounced a suspended prison sentence on the defendants.¹²¹ Other instances of pressure on media include online harassment of a female journalist¹²² and police officers approaching and demanding identification of journalists while they were reporting on an event of high public interest, even when it was obvious that they were media workers with professional equipment.¹²³

Vulnerable groups and the principle of non-discrimination

Between July and September, the Commission for Prevention and Protection against Discrimination (CPPD) issued several decisions and opinions. In July, the CPPD issued a general recommendation to the municipalities, calling on them to undertake systemic and non-discriminatory measures and activities to ensure adequate housing, urban planning, legalisation of homes, connections to public infrastructure, as well as administrative support and services for members of the population living in informal and substandard settlements, especially Roma.¹²⁴ It issued several decisions establishing both direct and indirect discrimination on various grounds, including the following cases: dismissal of a textile worker after requesting sick leave to care for her two-year-old child;¹²⁵ firing a worker after she announced her pregnancy;¹²⁶ discrimination based on gender and age;¹²⁷ discrimination in the area of access to healthcare based on disability in several psychiatric hospitals;¹²⁸ firing a physical education teacher based on his presumed political affiliation;¹²⁹ discrimination in the area of access to adequate housing for marginalised groups, predominantly Roma citizens, in various municipalities.¹³⁰

Several developments, including legislative developments, unfolded in the reporting period regarding the rights of persons with disabilities. In July, the Ministry of Education and Science (MES) announced that, for the first time, educational assistants will be employed not only in primary schools but also in secondary schools, effective from September 2025, following recent legal changes aimed at improving inclusiveness in the education system.¹³¹ However, the Minister further declared that the permanent employment of the educational assistant is not possible,¹³² despite reactions from parents and educational assistants.¹³³ The public call for educational assistants in secondary education was published on 5 August.¹³⁴ In light of the local elections scheduled for 19 October, implementation of the court ruling by the Appellate Court in Skopje has failed, with many persistent gaps for the exercise of the right to vote, including many polling stations still lacking physical accessibility features, while institutions and parties face no apparent enforcement mechanism to ensure compliance.¹³⁵

In addition, there were public demands for simplified documentation procedures when applying for financial assistance, underscoring the bureaucratic barriers faced by many citizens with disabilities.¹³⁶ Furthermore, parents and caregivers are calling for formal recognition of the 'parent–caregiver' profession, ensuring their social protection and labour rights.¹³⁷

In July, the Government of North Macedonia proposed amendments to the Law on Employment of Disabled Persons, which will allow people with autism spectrum disorders and people with other pervasive developmental disorders to be employed.¹³⁸ In addition, in September, the Assembly of North Macedonia adopted the Law on Accessibility of Websites and Mobile Applications of Public Sector Institutions,¹³⁹ however the legislation still excludes the private sector and leaves out coverage for digital assistive devices, which remain largely unaffordable or unsupported by the state.¹⁴⁰

Gender

The Minister of Justice announced that with the latest proposed amendments to the Criminal Code, domestic violence perpetrators will be prosecuted ex officio, even without the victim filing a complaint, thus making a systemic change that relieves victims of pressure and fear of retaliation.¹⁴¹

The Prime Minister announced that the Government is considering introducing additional taxes for single people and unmarried people due to demographic challenges faced by the country, as measured by fewer marriages being concluded and fewer children being born. The Network for Protection from Discrimination reacted by stating that it is a threat to basic human rights and the principles of equality and freedom, and that such a tax would burden young people, single parents, LGBTI+ persons, and those who are socially and economically vulnerable. Its

On a separate occasion, the Gender Equality Platform responded to the draft amendments to the Law on Police, which were submitted to the Assembly, proposing the repeal of the provision that obliges respect for the principle of equality in employment within the police. The response stated that repealing this article sends a dangerous message that gender equality and inclusiveness are irrelevant in the construction of security institutions, and such a proposal represents a serious concern due to numerous cases of inappropriate treatment and ineffective protection by the police, especially in cases of gender-based and domestic violence.¹⁴⁴

The CPPD filed a lawsuit against the Government and the Ministry of Health before the Basic Civil Court Skopje because they failed to include female farmers in the provision of the Law on Health Insurance that lists beneficiaries of maternity leave compensation. While there is an annual programme allocating funds for maternity leave compensation for female farmers, a systematic resolution of this issue has not yet been achieved.¹⁴⁵

At the beginning of September, the National Network to End Violence against Women and Domestic Violence, together with the Helsinki Committee for Human Rights, organised a workshop at which the multisectoral body for monitoring cases of femicide and attempted femicide was officially established. This step was taken to ensure a systematic and coordinated approach to the prevention and monitoring of femicide, as well as the creation of policies for better protection and prevention of gender-based violence.¹⁴⁶

In late September, the constitutive session of the National Coordinating Body for the Implementation of the Council of Europe Convention on Preventing and Combating Violence against Women and Domestic Violence was held, during which all documents and activities adopted and implemented to date were presented.¹⁴⁷

The Commission for Financial Compensation for Victims of Violent Crimes received a total of 54 requests for compensation from victims of violence; however, it approved only one payment of EUR 500, while the rest were rejected as unfounded (32) or are ongoing (21).¹⁴⁸

On 11 July, while inspecting an illegal construction site, the Mayor of the City of Skopje was physically assaulted and threatened. According to her account, assailants verbally threatened her with rape and the murder of her family, and kicked her in front of police officers who did not intervene. The National Network to End Violence against Women and Domestic Violence strongly condemned the assault, stating that it attacked the dignity of women in general and also demonstrated that threats, belittlement, and violence increasingly target female politicians. Police detained two suspects, while the Basic Public Prosecutor's Office Skopje filed a case against one individual for violence. The Basic Criminal Court Skopje found the defendant guilty and sentenced him to two years' imprisonment.

On 15 September in Veles, a woman and her father were murdered by her former partner, who then committed suicide.¹⁵⁴ She had previously lodged multiple reports of threats and violence by her ex-partner, including threats to her family as well as physical attacks against her and property damage.¹⁵⁵ Although the police had been alerted, institutional action appears to have been insufficient to prevent the fatal escalation. The Ministry of Interior initiated disciplinary proceedings against 11 police officers for failure to act upon those complaints,¹⁵⁶ while citizens responded to the tragedy by organising a protest over their inaction.¹⁵⁷

Rights of the child

On 8 August, the Government of North Macedonia adopted the National Action Plan on Children's Rights 2025–2029, taking a significant step toward fulfilling its commitments to the UN Committee on the Rights of the Child and implementing the European Children's Rights Guarantee. A key component of the plan is the establishment of a national mechanism for coordination and monitoring of the implementation of the United Nations Convention on the Rights of the Child (UNCRC) through amendments to the Law on Child Protection. This will establish a specialised body for monitoring children's rights, which will be tasked with coordinating the implementation of the plan, as well as providing systemic oversight of the implementation of the UNCRC. The UNCRC.

LGBTI+

The Gender Equality Platform issued a public call ahead of the 2025 local elections, demanding that all political parties adopt dignified local policies for marginalised communities, including lesbian, gay, bisexual, trans and intersex communities (LGBTIQ+) and others at the intersection of social injustice. In July, the Ministry of Education and Science (MES) published a rulebook on the method of reporting and protecting a student-victim who are victims of violence, abuse and neglect (primary education), to which the Gender Equality Platform issued a reaction, criticising the Ministry for failing to prioritise measures to address violence, discrimination, and exclusion in education, arguing that new rulebook normalises harmful practices rather than prevent them, especially for LGBTI+ students.

Roma

Following his April visit, the Council of Europe Commissioner for Human Rights published a memorandum on North Macedonia addressing the human rights of Roma and the right to a clean and healthy environment. The report acknowledges progress, including the adoption of the Roma Inclusion Strategy 2022–2030 and improvements in primary school enrolment, but highlights persistent gaps in implementation, continuing discrimination, school segregation, and weak protection against police abuse. It also stresses that Roma communities are disproportionately exposed to environmental hazards due to inadequate housing and waste management. While North Macedonia has a solid legal framework for environmental protection, enforcement and access to justice remain limited. The Commissioner called for stronger institutional coordination, increased local-level funding, accountability in law enforcement, and full implementation of environmental and Roma-inclusion measures. In this regard, the Minister without portfolio responsible for Roma inclusion and implementation of the Roma Inclusion Strategy 2022-2030 also stated that combating antigypsyism in North Macedonia requires a systemic and comprehensive response rather than isolated initiatives. The supplementation of the Roma Inclusion comprehensive response rather than isolated initiatives.

A landmark court ruling was issued in July: the Basic Civil Court Skopje found that the Registry Directorate's failure to integrate individuals from the 'Special Birth Registry' into the regular registry constituted discrimination, disproportionately affecting Roma who were subsequently denied access to rights and services. In late July, the MES issued two public calls for the 2025–26 school year: one to recruit 50 Roma educational mediators to support primary education, and a new call to recruit 35 mediators for the first time in secondary education. In August, the United Nations (UN) Human Rights Committee found that North Macedonia had violated the rights of two Roma citizens at the border crossing at Tabanovce. In two cases, in 2014 and 2015, they were prevented from leaving the country despite having valid passports and documentation.

In September, the Director of the Protection and Rescue Directorate at the Government of the Republic of North Macedonia declared in a public appearance that the Roma families living in the informal settlement Vardrishte should be relocated "by a short procedure and, if necessary, by force". This declaration followed a massive fire outbreak at the Vardarishte landfill. The Ombudsman emphasised that the state must seek adequate and sustainable housing solutions rather than resorting to forced evictions, criticising public remarks calling for forced relocation of Roma communities as stigmatising, discriminatory, and contrary to the Constitution, the Roma Inclusion Strategy 2022–2030, and international human rights law. 168
