

This monitoring brief was prepared under the project Building bridges for a common future: Rule of law in view of EU accession, funded by the European Union. This brief summarises the key developments related to the rule of law in the context of North Macedonia's EU accession for the period October–December 2025. It includes **monitoring the fundamentals of EU accession, including key developments in the functioning of democratic institutions, public administration reform, and Chapter 23: Judiciary and Fundamental Rights.**

## Key developments

- » The 2025 local elections saw the lowest voter turnout in North Macedonia's history, with neither round exceeding 50% participation.
- » The Ministry of Public Administration launched a mandatory training for a modernised Human Resources Management Information System (HRMIS) to centralise payroll and digitalise personnel files across the public sector.
- » New digital tools were introduced, including “e-Kiosk” for immediate document access and “e-sandache” for secure institutional communication, aiming to improve service delivery.
- » After the Ministry of Finance confirmed a continued lack of funding following the adoption of the 2026 state budget, the Management Board of the Academy for Judges and Public Prosecutors decided to annul the 2023 admission announcement for the Academy's ninth generation of candidates.
- » The Assembly adopted a new Law on the Judicial Council in late December, introducing stricter criteria for members and new mechanisms for dismissing the Council's President.
- » In December, the Assembly elected a new president of the State Commission for Prevention of Corruption (SCPC).
- » A major bribery case involving EU Instrument for Pre-Accession Assistance for Rural Development (IPARD) funds emerged, in which the Director of the Agency for Financial Support in Agriculture was investigated for accepting a bribe, prompting the freezing of funds.
- » The process for selecting North Macedonia's judge for the European Court of Human Rights (ECtHR) was marred by allegations of conflict of interest and procedural shortcomings, drawing criticism from civil society and candidates.
- » The ECtHR ruled against North Macedonia in two cases involving dismissed judges, finding that their rights to a fair trial and to access to justice had been violated.
- » The Ombudsperson's office warned of a potential shutdown in January 2026 if the Assembly fails to elect a new Ombudsperson, leaving the institution without a signatory for salaries and key documents.
- » The election period saw serious violence against the Roma community, including the physical assault of a Roma candidate for municipal councillor in Vinica, who was beaten into a coma.

# Functioning of democratic institutions



# Elections

Local elections held in October 2025 were conducted in an overall orderly manner, with institutions stressing that voting largely proceeded in line with the legal framework. At the same time, the electoral process was marked by reported irregularities and complaints, pointing to persistent challenges related to electoral integrity.

The Public Prosecutor's Office and the Ministry of Interior reported cases related to vote-buying, photographing of ballots, agitation during election silence, and obstruction of voting. Several individuals were detained, while institutions underlined that the incidents were isolated.<sup>12</sup> The State Election Commission (SEC) addressed several procedural irregularities, including the annulment of a City of Skopje council list due to the inclusion of a deceased person,<sup>3</sup> corrections of ballot-printing errors in Novo Selo,<sup>4</sup> and complaints submitted by independent lists in the Municipality of Centar.<sup>5</sup>

The Ombudsperson opened a free hotline for reporting violations of voting rights during local elections, urging citizens to report pressure, obstacles to voting, and procedural irregularities.<sup>6</sup> Civil society organisations (CSOs) raised concerns about the electoral environment, particularly regarding hate speech. The Helsinki Committee reacted publicly, warning that hate speech during elections undermines democratic participation.<sup>7</sup>

The second round of local elections was held in November. According to the State Election Commission (SEC), voting proceeded without major disruptions, although incidents related to agitation, vote-buying, and procedural violations were again recorded.<sup>8</sup> The Organization for Security and Co-operation in Europe/ Office for Democratic Institutions and Human Rights (OSCE/ODIHR) Election Observation Mission (EOM) for the second round of local elections (2 November 2025) concluded that while the elections offered voters a *genuine choice between distinct political alternatives*, campaign conditions were not equal for all contestants. The ODIHR pointed to a media advertising allocation system that disadvantaged smaller and independent candidates, limited campaign finance reporting requirements, and continued involvement of government officials in campaign activities. Persistent allegations of pressure on public-sector employees and voters, and continued reports of vote-buying, were noted, alongside administrative and legal gaps in the regulation of second-round election procedures. Despite these concerns, the election administration was regarded as efficient and transparent, with procedures largely adhered to at polling stations.<sup>9</sup>

Final results confirmed VMRO-DPMNE as the party with the highest number of mayoral mandates, while independent lists secured a notable share of the vote.<sup>10, 11</sup> Voter turnout remained lower than in previous election cycles. The SEC reviewed appeals and complaints, including cases involving repeat voting at specific polling stations.<sup>12</sup> For the first time since the independence of North Macedonia, the turnout in the eighth local elections, in both rounds, did not exceed 50%, making these the elections with the lowest turnout in the country's history.<sup>13</sup>

In December, the SEC finalised post-election procedures<sup>14</sup>, including the replacement of Members of Parliament who were elected mayors.<sup>15</sup> The SEC also announced that new rounds of voting would be organised in four municipalities in January 2026, citing insufficient turnout and annulled voting results as required by the Electoral Code.<sup>16</sup>

## Assembly

Parliamentary activity in October was limited and shaped mainly by the local elections. Political debate focused primarily on election-related developments, while legislative output remained modest.

In November, the Assembly held a dedicated plenary session on the European Commission's 2025 Report. The debate included an address by the President of the Republic and interventions by the Prime Minister and MPs from both the ruling majority and the opposition. Discussions focused on constitutional amendments, rule-of-law reforms, and the credibility of the EU accession process.<sup>17, 18</sup> The debate exposed deep political polarisation, with divergent interpretations of who was responsible for the stagnation of reform.<sup>19</sup> In November, the Assembly held a session of the European Union–North Macedonia Joint Parliamentary Committee in Strasbourg, bringing together members of the national parliament and the European Parliament. Discussions focused on the country's EU accession process, the implementation of reform commitments, freedom of expression, good-neighbourly relations, and environmental issues. Participants underlined the importance of constructive parliamentary dialogue, effective oversight, and sustained reform momentum, while reiterating concerns related to polarisation and the need for inclusive political processes aligned with EU standards.<sup>20, 21</sup>

In December, the Assembly adopted several key decisions. It elected Adem Čučul as President of the State Commission for Prevention of Corruption (SCPC).<sup>22</sup> The Assembly also adopted the Law on the Judicial Council, with the governing majority presenting it as aligned with EU recommendations, while the opposition expressed concerns.<sup>23</sup>

Parliamentary oversight activities included an inquiry committee hearing on the Kochani tragedy and other tragedies<sup>24</sup>, as well as debates on migration, marked by competing resolutions from the ruling parties and the opposition.<sup>25</sup>

In the same month, representatives of the Ombudsperson's Office called on the Assembly to initiate and complete the process of appointing a new Ombudsperson, warning of the risks associated with a prolonged vacancy.<sup>26</sup>

## Governance

During October, executive action focused on EU integration-related processes and regional cooperation. The Government highlighted the approval of the second tranche of EU funds under the Reform and Growth Facility<sup>27</sup>, presenting this as confirmation of progress under the Reform Agenda and continued engagement with the EU accession process.

In the same period, North Macedonia hosted the Western Balkans Digital Summit in Skopje,<sup>28</sup> where regional leaders discussed digital integration and initiatives to reduce roaming costs between the Western Balkans and the EU.<sup>29</sup> October was also marked by intensified bilateral engagement with Bulgaria, particularly concerning Corridor VIII. Government representatives announced that construction of the railway tunnel on Corridor VIII was moving toward a formal agreement that would frame the project as a strategic infrastructure priority and part of European transport connectivity.<sup>30</sup> Government officials confirmed the signing of an agreement with Bulgaria to construct a joint railway tunnel, stressing EU support for the project and its importance for regional connectivity.<sup>31</sup>

Calls for early parliamentary elections were publicly dismissed by senior government representatives, including the Prime Minister and members of the governing coalition. They stated that early elections were not under consideration, citing the stability of the governing majority and the need to focus on governance, reforms, and implementation of the government programme.<sup>32, 33, 34</sup> The issue remained at the level of political discourse and did not translate into institutional procedures or formal parliamentary debate. At the same time, fact-checking analyses pointed to variations in the Prime Minister's public statements, noting a degree of ambiguity about the circumstances under which early elections could be considered.<sup>35</sup> While these differing signals contributed to continued public and political speculation, no formal steps were initiated by the executive or the legislature.

Governance discourse in November was strongly influenced by the publication of the European Commission's 2025 Report. Members of the Government publicly responded to the report, reiterating their commitment to EU integration while disputing parts of the assessment, particularly regarding constitutional amendments.<sup>36</sup>

In December, governance developments were marked by changes in government composition. The Assembly confirmed the appointment of Bekim Sali as Deputy Prime Minister for European Integration, strengthening political coordination of the EU agenda.<sup>37</sup> At the same time, Muhamet Hodža assumed office as Minister of Environment and Spatial Planning, following his election by the Assembly.<sup>38</sup> Public debate intensified following statements by senior executive officials regarding the work of the Public Prosecutor and certain judges. While framed as calls for accountability, these statements raised concerns about potential pressure on the judiciary and respect for the separation of powers.<sup>39, 40</sup>

In December, the Government also declared a crisis in electricity supply, citing difficulties securing mazut. The decision triggered political debate regarding preparedness and crisis management capacity.<sup>41</sup>

## Civil Society

The Council for Cooperation between the Government and civil society continued its regular work this quarter. It held three sessions (the 5<sup>th</sup>,<sup>42</sup> 6<sup>th</sup><sup>43</sup>, and 7<sup>th</sup> sessions<sup>44</sup> of this Council composition), with a clear focus on improving the enabling environment for CSOs, legislative reform, and monitoring of the Strategy for Cooperation with Civil Society 2025–2028. During these sessions, discussions focused on challenges related to public funding and the financial sustainability of CSOs, and on the use of the Electronic National Register of Regulations (ENER) for consultations with civil society. A review was performed of draft ‘indicator passports’ for monitoring the implementation of the aforementioned Strategy, as well as on improving communication channels between the Council and CSOs, including proposals for more direct and accessible communication mechanisms. Regarding potential improvements to the legal framework for CSOs, during these sessions, discussions focused on amendments to the Law on Associations and Foundations; the Law on Donations and Sponsorships in Public Activities; the Law on Volunteering; and the draft Law on Social Entrepreneurship. The Council selected its representatives to the working group on the new draft Law on Associations and Foundations, and the draft Law was published on the ENER on 31 December.<sup>45</sup>

## Civilian Oversight of the Security/ Intelligence Sector

Civilian and parliamentary oversight of the security and intelligence sector remained limited during the reporting period. Public attention was drawn to integrity issues following international recognition of investigative reporting by “360 Stepeni” concerning the educational credentials of the Director of the Agency for National Security.<sup>46</sup> In November, a publicly reported complaint concerning the Agency for Intelligence raised questions about compliance with legal requirements governing national security institutions. An anonymous complaint submitted to the State Commission for Prevention of Corruption (SCPC) alleged that certain employees were working without valid security clearance certificates. The Agency for Intelligence rejected the allegations, stating that all employment procedures complied with the law. The SCPC declared itself not competent and referred the case to the parliamentary oversight commission, underscoring the role of legislative oversight in addressing integrity concerns within security institutions.<sup>47</sup>

# Public Administration Reform

On 08 October 2025, the Ministry of Public Administration (MPA) launched mandatory training sessions for the modernised Human Resources Management Information System (HRMIS), aiming to fully implement it across all public institutions by the end of 2026. The upgraded system, fully owned by the state, enables centralised payroll processing, digital human resources management, interoperability, and direct employee access to electronic personnel files, supported by ongoing technical support and regular updates.<sup>48</sup>

The fourth session of the Secretariat for Public Administration was held on 13 October 2025, during which the draft updated Action Plan for the PAR Strategy 2023–2030 (updated for 2025–2026) was discussed. It was also noted that a new Public Administration Academy has been established and that the Ministry of Public Administration (MPA) is working to adopt a new Law on Senior Management Service, a new Law on the Organisation and Operation of State Administration Bodies, a new salary system, and other related reforms.<sup>49</sup>

A significant amount of older archive material has disappeared from ministerial websites following a poorly executed redesign, making it difficult to access historical government information. Key documents, such as the list of construction companies whose licenses were revoked after the Kochani nightclub fire and details of a EUR 70 million EBRD loan for Skopje's Bus Rapid Transit system, are no longer available. The redesign, aimed at unifying ministry websites, is behind schedule, leaving much recent official information accessible only through media republishing.<sup>50</sup>

During the promotion of the National Portal for Electronic Services in Bitola in November 2025, it was highlighted that the portal already has nearly 240,000 users and provides faster access to services. The successful example of electronic device vouchers for students was also highlighted, with 39,000 students applying and 20,800 already using the vouchers.<sup>51</sup>

On 11 December 2025, the two-day workshop 'Strengthening Capacities for Better Management of Regulatory Impact Assessment (RIA) in the Republic of North Macedonia' was held, organised by the MPA with support from the Support for Improvement in Governance and Management (SIGMA) initiative. The workshop was attended by civil servants from all sectoral ministries and relevant institutions, aiming to improve practical and analytical skills for managing RIA, as well as to ensure higher quality in the preparation of regulations.<sup>52</sup>

On 18 December 2025, the Venice Commission issued a positive opinion on the Draft Law on Equitable Representation, recommending the inclusion of more detailed provisions to clearly balance the principles of "adequate" and "fair" representation, establish concrete hiring procedures, and ensure that ethnic criteria do not undermine merit-based employment. The law should emphasise the primary role of qualifications, the secondary role of belonging to an underrepresented community, and the principle of proportionality for

special measures. It also calls for clear definitions of objective criteria for verifying candidates' self-identification, the designation of a competent authority, and the consequences of any abuse.<sup>53</sup>

The Ministry of Digital Transformation has announced a public call for municipalities and public-sector institutions to develop official websites. The initiative aims to improve digital infrastructure, transparency, and accessibility of local governments, and all entities are eligible to apply, regardless of their size or current website status.<sup>54</sup>

The new IT tool for monitoring the implementation of the Public Administration Reform Strategy was launched on 18 December 2025, aiming to inform all stakeholders (public institutions, the private sector, the academic community, and CSOs) about its use, significance, and benefits, as well as to encourage all participants to engage in active collaboration and implementation.<sup>55</sup>

On 19 December 2025, e-Kiosk (e-booth) and e-sandache (e-mailbox) were launched to improve digital inclusion and streamline public services. The e-kiosk allows citizens to access services and receive documents immediately, especially benefiting those in rural areas and those with limited internet access, while e-sandache provides a secure, legally valid channel for institutional communication with real-time notifications and case tracking, contributing to more efficient and accessible digital administration.<sup>56</sup>

# Chapter 23



# Functioning of the judiciary

In the second half of October, the Council for Monitoring Reforms in the Justice Sector held its second session. The meeting focused on reviewing key operational documents, including the draft Rules of Procedure and the Methodology for Monitoring and Measuring Reform Activities. Discussions highlighted the importance of strengthening inter-institutional coordination and ensuring the timely and consistent submission of data by all relevant institutions as prerequisites for effective monitoring and transparent reporting on reform implementation.<sup>57</sup>

## Management bodies

Following the EU Peer Review Mission's identification of shortcomings in the Law on the Judicial Council, the Ministry of Justice established a working group to draft a new law.<sup>58</sup> The working group held 23 meetings, and its work led to the Assembly's adoption of the new Law on the Judicial Council in late December.<sup>59</sup> The law introduces amendments to strengthen the legal framework, including provisions on the dismissal of the President of the Judicial Council, stricter eligibility criteria for lay members, and enhanced transparency and accountability mechanisms, addressing key recommendations of the Peer Review Mission.<sup>60</sup>

In October, the Venice Commission of the Council of Europe adopted a Joint Opinion on the draft laws on the Public Prosecutor's Office and the Council of Public Prosecutors.<sup>61</sup> The Opinion recommended reinforcing the Council of Public Prosecutors' role in safeguarding prosecutors from external pressure and clarifying disciplinary procedures to prevent their misuse.<sup>62</sup> Subsequently, the Government adopted the draft Law on the Public Prosecutor's Office, which entered further phases of the legislative procedure in the Assembly.<sup>63</sup>

Regarding changes to the composition of governance bodies, the Judicial Council published an announcement in November to elect a member from among judges who belong to the community representing more than twenty per cent of the population.<sup>64</sup> The Parliamentary Committee on Election and Appointment Issues proposed a candidate currently employed as a police inspector in the Ministry of Interior.<sup>65</sup> The proposal prompted criticism from the Blueprint Group for Justice Reform, which raised concerns about professional standards and transparency, particularly given that the forthcoming legislative framework had not yet entered into force.<sup>66</sup>

On 9 December, the Council of Public Prosecutors elected a new president and deputy president.<sup>67</sup>

At its 533<sup>rd</sup> session, the Judicial Council adopted its Annual Work Program for 2026, with an Action Plan.<sup>68</sup> At the end of November, it also publicly presented the Draft Program and Action Plan for Prevention and Monitoring of Corruption in the Judiciary 2026–2029, which is aimed at addressing corruption influenced from outside, but also within the judicial system, with the ultimate goal of consolidating judicial independence, merit-based governance, accountability, and restoring public trust in the country's judicial system.<sup>69</sup>

At its 29<sup>th</sup> session, the Council of Public Prosecutors adopted its Strategy for Communication and Transparency for 2025–2028,<sup>70</sup> and later established a Commission to implement it.<sup>71</sup> At the same session, it adopted the Rulebook on Conducting a Procedure for Ensuring and Guaranteeing the Independence of Public Prosecutors.<sup>72</sup>

## Independence and impartiality

During the reporting period, the Judicial Council, the Supreme Court, and the Association of Judges issued a joint open letter to the Prime Minister in response to his public statements about the judiciary and its budget allocation.<sup>73</sup> The letter rejected claims linking the judiciary to the state's overall fiscal situation, including public debt. It stressed that the judiciary's financial dependence on the executive branch continues to pose a structural challenge to judicial independence.<sup>74</sup>

Following earlier exchanges with the Ministry of Finance regarding budgetary allocations for employment,<sup>75</sup> the Judicial Budget Council, at its 257<sup>th</sup> session, reviewed the Ministry's negative opinions on the annual employment plans for the judiciary for 2026. The Council agreed to request an urgent meeting with the Minister of Finance to address the lack of consent for new employment, noting that persistent human resource shortages in courts and prosecution offices continue to affect their operational capacity and efficiency.<sup>76</sup>

Toward the end of the year, the Ministry of Justice published the 2025 minutes of the Commission for Supervision of the Automated Court Case Management Information System (ACCMIS). The supervision, conducted in 15 courts, revealed that all cases were distributed exclusively through ACCMIS, with no instances of manual distribution found. The courts face significant challenges, including a shortage of judges and court staff, the technological obsolescence of the ACCMIS system, and the conclusion that delegating tasks to judges is not a sustainable long-term solution.<sup>77</sup>

## Professionalism and competence

At its 529<sup>th</sup> session, the Judicial Council adopted a decision on the temporary assignment of a judge of the Basic Court Gostivar to perform the judicial function in the Basic Court Kichevo for a period of one year, starting from 16 October 2025.<sup>78</sup>

At its 533<sup>rd</sup> session, the Judicial Council appointed an acting president of the Administrative Court.<sup>79</sup> Shortly after, in the second half of November, it published a public announcement for the election of the President of the Administrative Court,<sup>80</sup> as well as an announcement for the election of the President of the Basic Court Berovo, Basic Court Delchevo, and Basic Court Radovish.<sup>81</sup>

At its 33<sup>rd</sup> session, the Council of Public Prosecutors appointed an acting High Public Prosecutor of the High Public Prosecutor's Office Skopje, until the appointment of a High Public Prosecutor, for a period not longer than six months.<sup>82</sup>

At its 34<sup>th</sup> session, the Council of Public Prosecutors decided to publish an announcement for the election of a High Public Prosecutor of the Higher Public Prosecutor's Office in Skopje and to publish an announcement for the election of five public prosecutors in the Basic Public Prosecutor's Office for Prosecution of Organised Crime and Corruption.<sup>83</sup> At the end of November, the Council published an announcement for the election of a Basic Public Prosecutor in the Basic Public Prosecutor's Office in Skopje and a Basic Public Prosecutor in the Basic Public Prosecutor's Office in Tetovo.<sup>84</sup>

Following the Government's proposal to dismiss the Public Prosecutor of the Republic of North Macedonia,<sup>85</sup> the Public Prosecutor resigned from that position.<sup>86</sup> At its 35<sup>th</sup> session, the Council of Public Prosecutors appointed an acting Public Prosecutor of the Republic of North Macedonia, until the appointment of a Public Prosecutor of the Republic of North Macedonia, for a period not longer than six months.<sup>87</sup>

## Quality of justice

Following the instruction of the Management Board of the Academy to address the Ministry of Finance regarding allocation of funds for admission of candidates in the Academy's ninth generation in 2026,<sup>88</sup> at its 240<sup>th</sup> session, the Management Board reviewed the Ministry's response informing the Academy that the Ministry cannot comment on this issue because the Budget of the Republic of North Macedonia for 2026 has not yet been adopted by the Assembly of the Republic of North Macedonia.<sup>89</sup> The Management Board instructed the Academy to address the Ministry again regarding the same issue urgently. At its next session, it was decided to postpone the decision on the ninth generation until the adoption of the state Budget.<sup>90</sup> Following its adoption, at the end of the year, the Management Board decided to annul the public announcement for the admission of 130 candidates into the Academy's ninth generation, as the announcement pursuant to which they were admitted was published in 2023 and is now rendered obsolete due to a continuous lack of financial resources to fund this generation.<sup>91</sup>

During this quarter, another Constitutional Court judge resigned,<sup>92</sup> leaving its composition short by two judges. The Judicial Council stated that they have no authority over the resignation and that the Assembly will regulate it. At the same time, for the other empty seat, they expressed hope that a replacement proposal would be finalised by year's end, despite internal disagreements on how to proceed after the Administrative Court annulled her election.<sup>93</sup> However, the Judicial Council session scheduled for 24 December to address this "precedent" and the court verdict was postponed due to a lack of quorum.<sup>94</sup> It has been rescheduled for 12 January 2026, when the Council is expected to finally discuss this matter.<sup>95</sup>

## Efficiency

Toward the end of the year, the Judicial Council and the Administrative Court concluded a memorandum of cooperation for digital connectivity between these institutions in administrative court procedures for the timely exchange of acts and documents, simplification and acceleration of procedures, strengthening legal certainty and transparency, reducing costs and establishing an effective system for two-way communication—exchange of documents (e-delivery).<sup>96</sup>

# Fight Against Corruption

## State Commission for Prevention of Corruption

Following the initiation of court proceedings against the former President of the SCPC<sup>97</sup> and the Assembly's public announcement of the election of a new President of the SCPC,<sup>98</sup> the election process continued during this quarter. Thirteen candidates applied;<sup>99</sup> the Committee on Elections and Appointments narrowed the list to 10 qualified candidates, who proceeded to the interview stage.<sup>100</sup> Following the interviews,<sup>101</sup> at the beginning of December, the Assembly elected a new President of the SCPC.<sup>102</sup>

During this quarter, preparations for the National Strategy for the Prevention of Corruption and Conflict of Interest 2026–2030 continued. Thematic consultative meetings<sup>103</sup> and multiple workshops were organised by the SCPC with relevant stakeholders in the areas covered by the new Strategy: transport and infrastructure,<sup>104</sup> urbanism and spatial planning,<sup>105</sup> supervision of the implementation of laws,<sup>106</sup> public procurement,<sup>107</sup> the health sector,<sup>108</sup> the judiciary,<sup>109</sup> and the environment, energy, and natural resources.<sup>110</sup> Additionally, the SCPC adopted a Corruption Risk Assessment and the Methodology for developing the Strategy.<sup>111</sup>

The SCPC promoted the first Action Plan for the Promotion of the Gender Perspective 2026–2030, which represents a practical framework for fairer, more inclusive, and more accountable policies, through which the SCPC intends to strengthen its capacity to identify and reduce gender-specific corruption risks.<sup>112</sup>

Following the October local elections, the SCPC published its election campaign donation reports, which revealed data on the transparency of campaign financing. During the first reporting period, only 35% of participants submitted their donation reports on time, including all 19 coalitions, but only 18 political parties and 24 independent candidates.<sup>113</sup> In the second reporting period, compliance dropped slightly to 33%, with reports submitted by all 19 coalitions, 17 political parties, and 21 independent candidates.<sup>114</sup> Regarding mayors' asset declarations, the SCPC found significant non-compliance with the legal obligation to declare assets: 35 former mayors failed to submit an asset declaration after their terms ended, and 19 newly elected mayors failed to submit one within the mandatory 30-day period after taking office. The SCPC announced that it will initiate misdemeanour proceedings against these individuals.<sup>115</sup>

## The Public Prosecutor's Office

This quarter was marked by a bribery case involving IPARD funds. The initial investigation revealed that a company manager promised a EUR 50,000 bribe to the Director of the Agency for Financial Support in Agriculture to secure the illegal approval of an IPARD grant, and that the Director accepted part of the bribe (found during a search).<sup>116</sup> As further investigation is ongoing, IPARD funds remain frozen, and the national institutions have not specified when the funds will be unblocked.<sup>117</sup>

An investigation was also opened into potential abuse of official position and authority in the Agency for Commodity Reserves. Four former officials and one expert witness were suspected of abusing their positions by submitting false information to the Government to justify the write-off of a shortage of 1,500 tons of wheat and 500 tons of barley (valued at EUR 473,000 or MKD 29.1 million).<sup>118</sup>

A former State Attorney was arrested on 13 December on suspicion of accepting a bribe for illegal influence.<sup>119</sup> According to the investigation, he demanded and later received a larger sum of money to use his influence to bribe a judge at the Appellate Court in Skopje to revoke a detention order for an inmate.<sup>120</sup>

Investigations were initiated for the following: money laundering and usury against 12 suspects operating a criminal ring offering loans with exorbitant interest rates;<sup>121</sup> abuse of the procedure for public call, award of public procurement contracts, or public-private partnerships, and embezzlement in the service against 32 natural persons and legal entities abusing public procurement procedures at the Prilep Hospital and against eight natural persons; one legal entity was suspected of organising a tender for moving equipment from REK Oslomej to REK Bitola, favouring one company;<sup>122</sup> abuse of official position and authority against two owners of two private elderly care homes in Skopje, who accommodated more residents than legally permitted, in substandard conditions;<sup>123</sup> criminal association, abuse of procedure for public call, abuse of official position, and money laundering against 33 persons, including officials at ESM Heat Distribution and company owners, who manipulated a tender, awarding the contract to a company with a higher bid;<sup>124</sup> criminal association, usury, and money laundering against eight persons organising illegal gambling without a licence in Skopje.<sup>125</sup>

## Legal framework

The Platform of Civil Society Organizations Fighting Against Corruption has demanded the urgent adoption of the proposed Law on the Protection of Whistleblowers, expressing serious concern over the unjustified delays.<sup>126</sup> Despite the draft being prepared and debated as early as December 2023, the law has remained stalled for two years, even as the European Commission warned that current protections are insufficient and that whistleblowers continue to face harassment and retaliation.<sup>127</sup>

# Fundamental Rights

## Case law of the European Court of Human Rights

In the last quarter of 2025, developments related to the European Court of Human Rights (ECtHR) were dominated by the selection process for ECtHR judges, controversies, and new case law concerning North Macedonia.

At the beginning of October, the Commission for the Selection of a Candidate from the Republic of North Macedonia for a judge at the European Court of Human Rights established a list of 11 eligible candidates for interview.<sup>128</sup> The procedure provoked significant public scrutiny. One of the candidates from the first call sent a letter to the Council of Europe, warning that the candidate list had been established amid serious procedural shortcomings and political interference, and that the second call for candidates was published during the election period, further stating that the Government was running parallel and conflicting procedures in the candidate selection process, thereby undermining legal certainty and transparency.<sup>129</sup> Concerns were further amplified by a formal complaint about a conflict of interest, submitted to the State Commission for Prevention of Corruption (SCPC), against an academic mentor who was simultaneously involved in the selection process, raising questions about impartiality and compliance with integrity standards.<sup>130</sup> On 20 October, the Commission conducted interviews with the 11 shortlisted candidates.<sup>131</sup> However, CSOs invited as observers criticised the interview process, noting that it lacked a clearly unified methodology, exhibited an uneven approach, weak coordination and management, unclear criteria, and insufficient or unclear language testing (English/French), which together cast doubt on compliance with merit-based selection standards.<sup>132</sup> In November, ongoing controversies surrounding the process saw the SCPC open three separate cases regarding potential conflicts of interest involving three members of the Commission for Selecting Candidates for Judge at the ECtHR, further delaying the selection process.<sup>133</sup> On 13 November, the SCPC recommended that three members of the selection commission step aside from voting on certain candidates due to potential conflicts of interest. However, the SCPC concluded that it was not competent to take further action, as no actual, legally recognised conflict of interest had been established.<sup>134</sup> On 26 November, the selection commission nominated three candidates – a professor and two lawyers – for appointment as judges at the ECtHR.<sup>135</sup> The names will be submitted to the Council of Europe's expert panel for a final assessment.

During the reporting period, the ECtHR issued two important judgments concerning North Macedonia. On 13 November, the Court delivered two judgments in the cases of Ribarev v. North Macedonia,<sup>136</sup> and Ilievska and Zdraveva v. North Macedonia.<sup>137</sup> Both cases concern the applicants' inability, under domestic law, to appeal against decisions of the State Judicial Council (SJC) dismissing them from their posts as judges, following the remittal of their cases by a second-instance panel of the Supreme Court (the Appeal Panel). The cases also concerned the manner in which the SJC applied the relevant statutory provisions when determining whether the requests for their dismissal had been lodged in time. In both judgments, the ECtHR found that there had been violations of Article 6 of the European Convention on Human Rights (ECHR), namely the right to a fair trial. The Court considered that the applicants' right of access to the Appeal Panel, even in proceedings prior to remittal, was effectively deprived of any substance. The ECtHR concluded that the applicants' right of access to a court had been restricted to such an extent that the very essence of that right was impaired.

In addition, in November, the ECtHR opened a case following a complaint by former Minister of Interior Gordana Jankulloska regarding the 'Tank' case. The ECtHR will examine whether there has been a violation of the right to a fair trial in the domestic proceedings in North Macedonia. Jankulloska publicly stated that, although nearly five years have elapsed since she filed the application, and she believes she was subjected to an unjust sentence, it is still personally significant to her that the ECtHR has recognised the alleged violations to the extent of opening the case.<sup>138</sup>

## The Ombudsperson

During the reporting period, the Ombudsperson continued to face institutional challenges that affected the institution's functioning. Through an open letter sent on 11 December,<sup>139</sup> staff, together with the two remaining deputy ombudsmen, appealed to the Assembly to urgently elect a new Ombudsperson, warning that from 1 January 2026 the institution could effectively "shut down", since without an elected Ombudsperson there is no one to sign the final account and key documents necessary for the institution to function, such as salaries, rent, and utilities.<sup>140</sup> In addition, the office warned that, starting in January 2026, this situation would affect staff's social, health, and pension contributions. Following this, the president of the Assembly urged all parliamentary groups to show political will and reach a compromise to elect a new Ombudsperson, stating that it was unacceptable for the institution to be without a head for so long.<sup>141</sup>

During the local elections in 2025, the Ombudsperson's office opened a dedicated telephone line for the first round in October<sup>142</sup>, reinforcing efforts to enhance direct communication with citizens and facilitate reporting of violations related to the right to vote.

## Prison and detention facilities

During the reporting period, developments related to prison and detention facilities were marked by recurring concerns over detention conditions and the treatment of vulnerable groups and minors, alongside isolated measures to improve child-friendly facilities.

On 2 October, media reported on the case of a 79-year-old man from Veles who had been convicted of sexual harassment, described as the first person in North Macedonia to serve a three-month house-arrest sentence with an electronic ankle monitor instead of going to prison. This measure was seen as a response aimed at reducing prison overcrowding.<sup>143</sup> Regarding the case of the 14-year-old girl in September, who had been kept locked in a cell for up to 22 hours a day in the Idrizovo prison, the Ombudsperson opened a case concerning the child and successfully arranged her transfer to the Tetovo Correctional Facility in Volkovija, where she now has an entire building to herself.<sup>144</sup> In another case, a prisoner in the Shtip penitentiary with an amputated leg was initially housed on the third floor and later provided with unsuitable sleeping arrangements. Still, after urgent action by the Ombudsperson, he was moved to accessible and appropriate accommodation, and his access to hospital treatment was secured.<sup>145</sup>

On 21 November, it was reported that a children's corner was opened at Idrizovo prison to improve conditions for child visits and support the well-being of children of incarcerated persons.<sup>146</sup> On 16 December, it was reported that a court hearing concerning a former prison director would continue on 26 December at the request of the public prosecutor, reflecting ongoing judicial scrutiny of prison management and accountability.<sup>147</sup> On the same day, the media reported that a 40-year-old convicted person from Skopje was found dead in the prison in Štip, drawing attention to issues of inmate safety, health care, and the duty of care owed by the authorities to persons deprived of liberty.<sup>148</sup>

## Freedom of thought, conscience and religion

Developments related to freedom of thought, conscience and religion were primarily linked to the use of religion in the political sphere and public debate on religious education. October saw renewed public debate on proposals to introduce mandatory religious education in schools, raising questions about the role of religion in public education and the respect for freedom of conscience.<sup>149</sup> A survey-based report indicated that a significant share of citizens perceived the use of religion in electoral campaigning. The report notes that Albanian political parties were most frequently associated with the use of religion during elections; however, respondents expressed disapproval of mixing religion and politics and reported that they rarely voted based on religious appeals.<sup>150</sup> This still raises concerns about the instrumentalisation of religious identity in political processes.

## Freedom of expression

During the reporting period, developments in freedom of expression were marked by intensive electoral-period media regulation and court proceedings, and recurring threats and pressure against journalists. In October, developments concerned complaints and initiatives submitted by the political party Levica regarding alleged group political advertising and media conduct. On 3 October, the Basic Civil Court Skopje rejected as unfounded Levica's request for a temporary measure within its lawsuit against the Agency for Audio and Audiovisual Media Services (AAVMS), which would have prohibited the Agency from distributing the Guidelines for Broadcasters for the 2025 Local Elections to commercial media outlets, and from submitting the report on broadcast paid political advertising (PPA) to the State Election Commission (SEC), which uses that report as the basis for allocating and disbursing funds for PPA.<sup>151</sup> In addition, on 6 December, the Administrative Court issued a decision dismissing Levica's lawsuit seeking to annul the same guidelines.<sup>152</sup> On 15 October, the Constitutional Court decided not to open proceedings against the AAVMS Guidelines, explaining that the act is based on and operationalises the legal provision of the Electoral Code. Therefore, the Court did not identify a legality problem in the Guidelines themselves.<sup>153</sup>

In October, the AAVMS published a monitoring report on pre-campaign media coverage (10 August through 28 September 2025), covering nine national TV services. The AAVMS states that no violations of the Electoral Code were found during that period, while noting limited election-related reporting overall, and it also highlights exceptions to balanced treatment.<sup>154</sup> In addition, on 6 November, the AAVMS published its report on broadcasters' paid political advertising for the first round of elections (29 September through 17 October 2025).<sup>155</sup> On 19 October, during the first round of elections, the Association of Journalists of Macedonia (AJM)

appealed to the SEC, municipal election commissions, and the Ministry of Interior to ensure unhindered access and working conditions for journalists at polling stations, citing reported incidents of obstruction and disputes over “accreditation” requirements.<sup>156</sup> In addition, the AAVMS initiated misdemeanour proceedings against two TV channels for alleged breaches of election silence during the first round of local elections,<sup>157</sup> and initiated additional misdemeanour proceedings against two other TV channels, alleging that during the election silence period, they aired statements/press content from the Minister of the Interior.<sup>158</sup>

Furthermore, on 21 November, the AAVMS opened a public consultation on the Draft Guide for influencers, vloggers, and content creators, which aims to help these creators comply with the Law on Audio and Audiovisual Media Services and related by-laws.<sup>159</sup> The Guide was later adopted on 25 December.<sup>160</sup> On 26 December, a new director of the AAVMS was appointed.<sup>161</sup>

On 15 October, the regional SafeJournalists network adopted a Declaration to advance the safety of women journalists in the Western Balkans. The Declaration was endorsed by a wide range of actors, and it underscores that women journalists face disproportionate risks, including online harassment, intimidation, workplace discrimination, and gender-based violence.<sup>162</sup>

Attacks against journalists and media continued in the reporting period, consisting of malicious online attacks against news media<sup>163</sup>, which were reported to the Ministry of Interior;<sup>164</sup> online threats and hate speech;<sup>165</sup> and a direct physical attack towards a journalist and a media outlet during a live broadcast.<sup>166</sup> The attack was condemned by the ruling party<sup>167</sup> and the AJM,<sup>168</sup> with the Skopje Basic Public Prosecutors’ Office later filing an indictment against the attacker.<sup>169</sup> In response to the “Resolution condemning the manipulations of opposition and confirming policies against illegal migration”, the AJM and the Independent Union

of Journalists and Media Workers (SSNM) warned that several broadly worded passages in the draft could be problematic for media freedom, because they loosely link “disinformation” and “spreading panic” with the potential use of the Criminal Code and other legal provisions, without clearly distinguishing between propaganda and opinion and professional journalism.<sup>170</sup> Furthermore, on 14 November, the AJM’s Council of Honour decided on three complaints regarding unethical conduct by a journalist related to unverified claims and evaluative/sexist remarks that contributed to victim-blaming and additional stigmatisation in a case involving the tragic death of a student.<sup>171</sup>

## Vulnerable groups and the principle of non-discrimination

Between October and December, the Commission for Prevention and Protection against Discrimination (CPPD) made several institutional changes. On 7 November, the CPPD announced that, following the rotation principle set out in the anti-discrimination law, its members elected Dushan Tomshich as the new President of the CPPD.<sup>172</sup> On 24 November, the CPPD published an internal vacancy notice for the promotion of two administrative employees;<sup>173</sup> on 3 December, the Assembly of North Macedonia published a public call to select three members of the CPPD;<sup>174</sup> and on 15 December, the CPPD adopted a decision to fill two positions through internal promotion.<sup>175</sup> Regarding the selection process for three members of the CPPD, the Network for Protection against Discrimination called on the Assembly to ensure the process was transparent and merit-based, prioritising independence, expertise, impartiality, and adequate representation.<sup>176</sup> The CPPD issued several decisions establishing both direct and indirect discrimination on various grounds, including the following cases: discrimination in employment;<sup>177</sup> two cases of discrimination due to pregnancy, which resulted in non-extension of contracts<sup>178</sup> and pregnancy loss;<sup>179</sup> discrimination of 12,000 pensioners living abroad who were excluded from the second linear pension increase;<sup>180</sup> and harassment of a school cleaner by a superior.<sup>181</sup> During this period, the CPPD also strongly condemned the rise of hate speech on social

media, citing an incident in which an individual allegedly insulted and discriminated against the entire Roma community, causing widespread public reaction and distress.<sup>182</sup>

Between October and December, developments concerning persons with disabilities were dominated by accessibility barriers and developments, gaps in social protection and institutional care, and heightened concern over budgetary decisions affecting support services. October marked the start of the local 2025 elections. Although the lack of accessible voting arrangements was acknowledged during the 2024 elections, no meaningful progress was made for the 2025 elections, and persons with disabilities continue to face physical and procedural barriers in exercising their right to vote.<sup>183</sup> A dedicated study on the participation of visually impaired persons in elections further documented persistent obstacles, raising concerns about the appropriateness of assistance and the secrecy of the ballot, and the problematic framing of disability within election administration.<sup>184</sup> During this period, the AAVMS also reminded that for the local elections, the public broadcaster and state-level TV stations that air paid political advertising must broadcast election-related content in a format accessible to persons with disabilities, including at least one daily news edition (16:00–24:00) and at least one additional election-related programme weekly (16:00–24:00) with accessibility features.<sup>185</sup> In addition, the Assembly of North Macedonia has integrated advanced accessibility technologies into its website, including a digital assistant/mechanisms intended to make parliamentary information easier to access for people with visual, motor and cognitive disabilities.<sup>186</sup> Further in accessibility and reasonable accommodation in October, after an intervention from the Ombudsperson, a 70-year-old prisoner with an amputated leg in the Shtip penitentiary who was for a long period housed on the third floor and forced to climb stairs was moved to ground-floor accommodation, after which a second intervention ensured he was assigned a suitable lower bunk.<sup>187</sup>

Regarding legislative developments, for the first time, people with autism spectrum disorder (and other pervasive developmental disorders) were added by the newly adopted amendments to the Law on Employment of Disabled Persons, adopted in September 2025. Employers can now hire them under this framework and apply for state support to adapt workplaces.<sup>188</sup> Discrimination was also prevalent, with the case of a 21-year-old employee of the City of Skopje with Down syndrome, who was pushed and harassed by a colleague in the workplace.<sup>189</sup> The cases prompted protests by parents of persons with disabilities and were filed with the CPPD.<sup>190</sup>

Delays and uncertainty surrounding the payment of the mobility allowance, which directly affect beneficiaries' independence and daily functioning, were reported in November.<sup>191</sup> In another case in December, the police in Tetovo filed criminal charges against seven individuals, including the former director of the Tetovo Centre for Social Work and other staff, on suspicion of abuses linked to the granting of disability-related compensation. According to the police, the benefit was approved in 2024 through decisions issued without adequate verification of eligibility, allegedly supported by falsified medical documentation and false statements.<sup>192</sup> During November and December, concerns grew about the anticipated reduction in the budget for the rare disease programme in the 2026 state budget,<sup>193</sup> a move perceived as endangering the continuity of therapy and effectively forcing patients into "rationing" scenarios.<sup>194</sup> Patient organisations publicly demanded increased funding,<sup>195</sup> while civil society coalitions and the national alliance of rare diseases called for responsible budget decisions to protect the rights and dignity of persons with disabilities<sup>196</sup> and rare diseases.<sup>197</sup>

## Gender

In the period between October and December, the case of a pregnant woman whose organs were removed during a caesarean section<sup>198</sup> continued to expose serious concerns regarding judicial delays and accountability in cases involving medical malpractice with gendered impacts. In October, the third judge assigned to the case remained on the proceedings despite defence requests for recusal, while Veaposka publicly described her ongoing physical and psychological suffering following the removal of her organs during childbirth.<sup>199</sup> In November, the trial was again postponed due to the absence of expert witnesses, further prolonging the proceedings and intensifying concerns over access to justice and the secondary victimisation of the survivor.<sup>200</sup> Later in November, a first-instance verdict was delivered, sentencing the gynaecologist involved to three years' imprisonment and a five-year professional ban, while other defendants were acquitted, an outcome that closed one procedural stage but continued to raise broader questions about institutional responsibility and effective redress for women harmed within the healthcare system.<sup>201</sup>

October also included socio-economic gender equality concerns. Reporting on rural women highlighted systemic discrimination affecting registered women farmers, including unresolved access to paid maternity leave and work absence rights. It also referenced that the CPPD had recognised systemic discrimination in access to equal rights compared to women workers in other sectors.<sup>202</sup> Menstrual poverty also emerged as a concrete equality issue in October, when a local study reported that a significant number of secondary-school girls from socially at-risk families could not afford menstrual products, leading to limited distribution through dispensers in one school through private donations.<sup>203</sup> The local elections held in October also shed light on women's representation in politics, where, despite 32 women competing for mayoral seats in the local elections, only four were elected, further illustrating the persistent underrepresentation of women in executive local positions.<sup>204</sup> Moreover, public discourse included statements and commentary reinforcing traditional motherhood expectations as a "biological task," positioning women primarily through their reproductive and caregiving roles, reflecting ongoing societal contestation around women's roles.<sup>205</sup>

Developments in November further exposed the socio-economic impacts of violence. A report highlighted that women face severe economic consequences after violence, including being prevented from working and losing jobs, and that many take loans or borrow money to survive in the early months after leaving violent situations.<sup>206</sup> Another study also highlighted harassment of women in public spaces, such as catcalling, stalking, and obstruction, among others, pointing to everyday insecurity and the normalisation of gendered harassment.<sup>207</sup> On 25 November, a platform for tracking femicides was promoted as a tool to identify systemic gaps and support early intervention.<sup>208</sup>

A report by the State Audit Office, assessing North Macedonia's implementation of the Istanbul Convention, highlights that key measures for prevention and victim protection remain incomplete and underfunded, with major gaps in specialised services and staffing. The auditors note that, of 52 planned activities in the Action Plan, 22 were implemented, 20 were not implemented, and 10 were partially implemented, and that there is still no specialised psychosocial treatment programme for perpetrators; the report flags systemic protection deficits, including that criminal prosecution for bodily harm is still largely initiated upon the victim's proposal rather than *ex officio*, and serious service gaps.<sup>209</sup>

**Another report captured material support gaps: survivors who report domestic violence to Centres for Social Work receive only MKD 15,000 (approximately EUR 250) as one-off assistance, while the state pro-**

vides no sustained support for core reintegration needs such as rent, utilities, food, children's education, psychological counselling, and employment support, factors that, they warn, often push women to return to abusive partners.<sup>210</sup> On the response side, Skopje City Council adopted a decision to open a shelter centre providing emergency accommodation and professional support until stabilisation and a long-term solution are found.<sup>211</sup>

On legal reforms, a group of MPs submitted amendments to the Criminal Code to align it with the Istanbul Convention by removing "prosecution upon the victim's proposal" for the offence of bodily injury when committed in the context of domestic violence, gender-based violence, hate-motivated violence, or against a particularly vulnerable person, meaning these cases would be prosecuted ex officio and prosecutors would act immediately without waiting for the victim to file a complaint.<sup>212</sup>

The education minister stated that NGO reactions to using the term "gender" would not block the adoption of a new education strategy, defending the term as referring to differences between males and females and pointing to the consultation process behind the strategy.<sup>213</sup> Menstrual equity was again dismissed when the Kisela Voda municipal council rejected an initiative for free menstrual products in primary schools.<sup>214</sup> Moreover, amendments to the Law on Labour Relations were proposed to prevent dismissals during pregnancy by automatically converting fixed-term contracts into open-ended contracts upon a pregnant worker submitting medical proof of pregnancy.<sup>215</sup>

During the reporting period, several cases of gender-based violence, domestic violence and femicide were reported including two cases of brutal assaults on partners,<sup>216</sup> stalking for two years of a former wife;<sup>217</sup> a physical attack on a wife and daughter and threatening them with a sharp object;<sup>218</sup> rape of a minor;<sup>219</sup> two other cases of assaults and threats with sharp objects against women by their husbands;<sup>220</sup> illegal deprivation of liberty and killing of a woman<sup>221</sup> which was framed explicitly as femicide and called for urgent institutional

reaction, stressing that femicide is not a “private matter”;<sup>222</sup> attempted murder;<sup>223</sup> kidnapping, killing, and concealing the body of a woman;<sup>224</sup> sexual assault/rape and subsequent blackmail.<sup>225</sup> The plethora of gender-based violence, domestic violence and femicide cases is further highlighted by the Eurostat 2023 data, stating that North Macedonia ranked highly in Europe for the rate of partner-perpetrated killings of women.<sup>226</sup>

## Hate speech

Between October and December, hate speech in North Macedonia remained visible across public discourse, social media, and local political contexts, prompting reactions from prosecutorial authorities, civil society organisations, and citizen initiatives.

In October, the Basic Public Prosecutor’s Office in Skopje filed an indictment proposal against a 59-year-old man for inciting hatred, discord, or intolerance after he allegedly directed Nazi salutes, insults, and threats in German at the director of the Holocaust Fund of the Jews from Macedonia.<sup>227</sup> As the local elections were held in October, the Helsinki Committee for Human Rights strongly reacted to hate speech used during the election campaign, calling on political actors to refrain from inflammatory rhetoric that fuels division and intolerance, highlighting that women candidates for mayoral and council positions were particularly exposed to hate speech and sexist attacks.<sup>228</sup> Later in the month, Roma civil society organisations condemned a racist statement made by a municipal councillor in Negotino, assessing the remarks as anti-Gypsyist hate speech that degrades the Roma community and incites exclusion from public and political life, pointing to the continued marginalisation of Roma communities and the lack of accountability for racist speech by public officials.<sup>229</sup>

In November, the Ohrid police filed a criminal complaint against a 57-year-old man from Ohrid on suspicion of spreading racist and xenophobic material via a computer system, after he allegedly posted a social-media post with photos that promoted hate speech.<sup>230</sup> At the same time, a graffiti containing hate speech in Skopje was removed by citizens after the municipality failed to act, highlighting gaps in institutional responsiveness and the role of civic engagement in countering hate speech in public spaces.<sup>231</sup>

In December, a published report<sup>232</sup> highlighted that social media are the main channel for hate speech in North Macedonia, with harmful content mostly generated by private individuals and amplified by sensationalist online media. Interethnic hate speech often receives high engagement on social networks among ethnic minorities. At the same time, gender-based hate is also prominent, with women commonly attacked based on their private lives rather than professional roles, reinforcing stereotypes and fueling hostility across ethnic and political lines.<sup>233</sup> Furthermore, an informal civic initiative filed a complaint with the Ombudsperson, alleging that the Prime Minister used insulting language and threatening messaging toward critics, the media, and political opponents, labelling them “the scum of society,” arguing that this fuels fear and intolerance.<sup>234</sup>

## Rights of the child

During the local 2025 elections, the Ombudsperson<sup>235</sup> issued appeals reminding participants in the local 2025 elections that involving children in political activities is an unacceptable form of instrumentalisation that violates children’s dignity and their right to protection from political influence under the Convention on the Rights of the Child, the Law on Child Protection, and the Electoral Code. In addition, the Helsinki Committee for Human Rights<sup>236</sup> condemned the increasing practice of involving children and minors in political activities ahead of the local elections, noting widespread social-media posts and campaign content where children are used for promotion. In November, the Ministry of Education and Science (MES) prepared a new national Education Strategy for the period 2026–2032, published on the government’s ENER platform for public consultation on 1 December.<sup>237</sup> The strategy emphasises continued reforms and builds on the current education framework, focusing on areas such as preschool education, inclusion in primary and secondary education, optimisation of the school network, new concepts for secondary and vocational education, and updated financing formulas for 2026 onwards.<sup>238</sup> On 27 November, the Sectoral Working Group on education, employment, and social policy convened, where the MES presented results from the previous six months and highlighted progress linked to the Western Balkans Growth Plan, including new funding formulas for primary and secondary education, provision of modern ICT equipment for primary schools, and expansion of dual education/work-based learning.<sup>239</sup>

A report in December highlighted the persistence of early pregnancies, noting that births to mothers under the age of 15 remain above the EU average, raising concerns about prevention, education, and access to reproductive health services for minors.<sup>240</sup> Sexual exploitation and sexual abuse of minors were prevalent, with

two serious cases. The first case concerns the repeated sexual abuse of a 16-year-old by her stepfather, while the mother, although aware and asked for help by the girl, neither reported nor prevented the abuse.<sup>241</sup> The second case concerns trafficking and sexual exploitation involving a 15-year-old girl, including the detention of suspects and ongoing criminal proceedings.<sup>242</sup> Both cases underscore the acute risks to child safety and the need for effective protection mechanisms.

## Roma

The reporting period began with developments around local elections and public reactions to anti-Roma incidents, highlighting both physical security risks and persistent discriminatory rhetoric. In early October, a Roma candidate for municipal councillor in Vinica was beaten and went into a coma.<sup>243</sup> The assault was condemned by the Ombudsman<sup>244</sup> and Roma civil society<sup>245</sup>, highlighting it as a serious incident with broader implications for participation and safety in political processes for Roma. In the 2025 local elections, Roma councillors were elected for the first time in several municipalities across the country, representing the community's interests and needs at the local level.<sup>246</sup> Later in October, Roma civil society organisations condemned a racist statement made by a municipal councillor in Negotino, assessing the remarks as anti-Gypsyist hate speech that degrades the Roma community and incites exclusion from public and political life, pointing to the continued marginalisation of Roma communities and the lack of accountability for racist speech by public officials.<sup>247</sup>

In November, developments involved both criminal accountability for racist expression and rights-protection actions involving Roma children. The Basic Public Prosecutor's Office in Kavadarci filed an indictment proposal against a 67-year-old resident of Negotino after he allegedly shared a video on 20 October on a social-media profile/page that used insulting language toward Roma and called for Roma to be banned from voting.<sup>248</sup> Separately, the European Roma Rights Centre (ERRC) reported filing a complaint with the Ombudsman concerning an incident involving an eight-year-old Roma child, who was threatened at knifepoint, forced to kneel and kiss the shoes of two adult perpetrators, and whose abuse was filmed and shared on Facebook. The ERRC called for stronger protective measures for the child, effective investigation, deterrent penalties, and public condemnation of anti-Roma violence.<sup>249</sup> Furthermore, on 20 November, a final ruling of the Skopje Court of Appeal confirmed that state authorities failed to implement the Law on Unregistered Persons in the Birth Registry, resulting in systemic exclusion and discrimination, disproportionately affecting

Roma registered in the “special birth register” who received identification documents that still block equal access to rights.<sup>250</sup>

In December, a new draft Law on Social Housing was publicly presented to ensure fair and dignified access to housing for vulnerable groups.<sup>251</sup> In addition, the Ministry of Education and Science introduced Roma education mediators in secondary education, presenting them as a step to strengthen support and inclusion for Roma students.<sup>252</sup>
